VITAL RECORDS FEES

SUMMARY OF HOUSE BILL 4786 (H-1) as Reported from Committee

The bill would amend the Public Health Code, Part 28 regarding Vital Records. The bill:

- Increases most existing fees for vital records searches, copies, authenticated copies, amendments to vital records, verification of vital records facts
- Authorizes fees for various expedited services
- Establishes new fee for a copy of a vital records-related document
- Establishes that a local registrar shall charge the same fee as the state registrar to a senior citizen for a search and one copy of their birth record
- Establishes the Vital Records Fund created within the State Treasury to receive revenue from fees for use by the vital records program, and to receive money or assets for any source. The Department of Technology, Management, and Budget is the administrator of the Fund for auditing purposes.
- Enacting section 1 establishes an October 1, 2013 effective date for the bill

The program includes 81.4 FTEs to support the state's vital records and statistics system, register all vital events, maintain data systems, issue copies of records, amend records, conduct fraud detection, and morbidity and mortality reports. In 2012, the Vital Records Section responded to 329,300 requests for services.

Vital records fees were last increased in 2004 when GF/GP funding was removed from the vital records program. Fees currently range from \$7 to \$40 for services. The bill proposes changes to establish fees at \$14 to \$50 for services. A schedule of the fees proposed by HB 4786 follows on page 2, including current law.

FISCAL IMPACT:

House Bill 4786 provides statutory changes upon which the FY 2013-14 budget for the Department of Community Health (DCH) is based in Enrolled HB 4328, Article IV. The FY 2013-14 DCH budget includes a \$1,500,000 increase in state restricted funding from increased vital records fees to maintain the current program. Total revenue from fees will increase from \$5.5 million to about \$7.0 million annually. Current fee levels are inadequate to support the program and available fund balances have been depleted. Total appropriations of vital records fees included in the FY 2013-14 budget are \$7,009,700.
