CHAPTER I

- Sec. 10c. (1) Except as otherwise provided in subsection (3), 3 conduct prohibited by law, or former law, and listed in subsection 4 (2) may be prosecuted in 1 of the following jurisdictions:
 - (a) The jurisdiction in which the offense occurred.
 - (b) The jurisdiction in which the information used to commit the violation was illegally used.
