

SUBSTITUTE FOR  
HOUSE BILL NO. 5231

A bill to amend 1931 PA 328, entitled  
"The Michigan penal code,"  
by amending sections 452, 455, 456, 457, 458, 459, and 460 (MCL  
750.452, 750.455, 750.456, 750.457, 750.458, 750.459, and 750.460).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 452. ~~Keeping, etc., a house of ill fame Any~~ A person who  
2 ~~shall keep, maintain~~ **KEEPS, MAINTAINS**, or ~~operate,~~ **OPERATES**, or aid  
3 **AIDS** and ~~abet~~ **ABETS** in keeping, maintaining, or operating, a house  
4 of ill-fame, bawdy house, or any house or place resorted to for the  
5 purpose of prostitution or lewdness ~~shall be~~ **IS** guilty of a felony  
6 ~~punishable by imprisonment in the state prison for not more than~~  
7 5 years or by a fine of not more than ~~2,500 dollars.~~ **\$5,000.00, OR**  
8 **BOTH.**

9       Sec. 455. ~~Pandering Any~~ A person who ~~shall procure a female~~

1 DOES ANY OF THE FOLLOWING IS GUILTY OF A FELONY PUNISHABLE BY  
2 IMPRISONMENT FOR NOT MORE THAN 20 YEARS:

3 (A) PROCURES AN inmate for a house of prostitution. ~~; or who~~  
4 ~~shall induce, persuade, encourage, inveigle or entice a female~~

5 (B) INDUCES, PERSUADES, ENCOURAGES, INVEIGLES, OR ENTICES A  
6 person to become a prostitute. ~~; or who by promises, threats,~~  
7 ~~violence~~

8 (C) BY PROMISE, THREAT, OR VIOLENCE, or by any device or  
9 scheme, ~~shall cause, induce, persuade, encourage, take, place,~~  
10 ~~harbor, inveigle or entice a female~~ CAUSES, INDUCES, PERSUADES,  
11 ENCOURAGES, TAKES, PLACES, HARBORS, INVEIGLES, OR ENTICES A person  
12 to become an inmate of a house of prostitution or assignation place  
13 ~~or any place where prostitution is practiced, encouraged, or~~  
14 ~~allowed. ; or any person who shall, by promises, threats,~~

15 (D) BY ANY PROMISE OR THREAT, OR BY violence or ~~by any device~~  
16 ~~or scheme, cause, induce, persuade, encourage, inveigle or entice~~  
17 CAUSES, INDUCES, PERSUADES, ENCOURAGES, INVEIGLES, OR ENTICES an  
18 inmate of a house of prostitution or place of assignation to remain  
19 ~~therein~~ THERE as such AN inmate. ~~; or any person who by promises,~~  
20 ~~threats,~~

21 (E) BY ANY PROMISE OR THREAT, OR BY violence, ~~by any device or~~  
22 ~~scheme, by fraud or artifice, or by duress of person or goods, or~~  
23 ~~by abuse of any position of confidence or authority, or having~~  
24 ~~legal charge, shall take, place, harbor, inveigle, entice,~~  
25 ~~persuade, encourage~~ TAKES, PLACES, HARBORS, INVEIGLES, ENTICES,  
26 PERSUADES, ENCOURAGES, or ~~procure~~ PROCURES any ~~female~~ person to  
27 ~~enter any place within this state in which prostitution is~~

1 ~~practiced, encouraged or allowed, for the purpose of~~ **ENGAGE IN**  
 2 ~~prostitution. , or who shall inveigle, entice, persuade, encourage,~~  
 3 ~~or procure~~

4 **(F) INVEIGLES, ENTICES, PERSUADES, ENCOURAGES, OR PROCURES** any  
 5 ~~female~~ person to come into this state or to leave this state for  
 6 the purpose of prostitution. ~~, or who upon~~

7 **(G) UPON** the pretense of marriage, takes or detains a ~~female~~  
 8 person for the purpose of sexual intercourse. ~~, or who shall~~  
 9 ~~receive or give or agree~~

10 **(H) RECEIVES OR GIVES, OR AGREES** to receive or give, any money  
 11 or thing of value for procuring or attempting to procure any ~~female~~  
 12 person to become a prostitute or to come into this state or leave  
 13 this state for the purpose of prostitution. ~~, shall be guilty of a~~  
 14 ~~felony, punishable by imprisonment in the state prison for not more~~  
 15 ~~than 20 years.~~

16 Sec. 456. ~~Placing wife by fraud, etc., in house of~~  
 17 ~~prostitution~~ ~~Any~~ **ANY** person who by force, fraud, intimidation, or  
 18 threat places or leaves, or procures any other person to place or  
 19 leave, his ~~wife~~ **OR HER SPOUSE** in a house of prostitution or to lead  
 20 a life of prostitution, ~~shall be~~ **IS** guilty of a felony ~~, punishable~~  
 21 ~~by imprisonment in the state prison for not more than 20 years.~~

22 Sec. 457. (1) ~~Accepting money, etc., from earnings of~~  
 23 ~~prostitute~~ ~~Any~~ **ANY** person who shall knowingly accept, receive, levy  
 24 **ACCEPTS, RECEIVES, LEVIES,** or appropriate **APPROPRIATES** any money or  
 25 valuable thing without consideration from the proceeds of the  
 26 earnings of any ~~woman~~ **PERSON** engaged in prostitution, or any  
 27 person, knowing a ~~female~~ **PERSON** to be a prostitute, ~~shall live~~ **WHO**

1 ~~LIVES~~ or ~~derive~~ **DERIVES** support or maintenance, in whole or in  
 2 part, from the earnings or proceeds of the prostitution of ~~said~~ **A**  
 3 prostitute, or from ~~moneys~~ **MONEY** loaned or advanced to or charged  
 4 against ~~her~~ **A PROSTITUTE** by any keeper or manager or inmate of a  
 5 house or other place where prostitution is practiced or allowed,  
 6 ~~shall be~~ **IS** guilty of a felony ~~, punishable by imprisonment in the~~  
 7 ~~state prison~~ **FOR** not more than 20 years. ~~And such~~

8 (2) **THE** acceptance, receipt, levy, or appropriation of ~~such~~  
 9 money or ~~valuable~~ **ANY** thing ~~, shall, upon any proceeding or trial~~  
 10 ~~for violation of this section, be~~ **OF VALUE DESCRIBED IN SUBSECTION**  
 11 **(1) IS** presumptive evidence of lack of consideration.

12 Sec. 458. ~~Detaining female in house of prostitution for debt~~  
 13 ~~contracted while there~~ ~~Any~~ **ANY** person who attempts to detain any  
 14 ~~female~~ person in a disorderly house or house of prostitution  
 15 because of any debt or debts ~~she~~ **THE PERSON** has contracted, or is  
 16 said to have contracted while living in ~~said~~ **THAT** house, ~~shall be~~  
 17 **IS** guilty of a felony ~~, punishable by imprisonment in the state~~  
 18 ~~prison~~ for not less than 2 ~~nor~~ **YEARS OR** more than 20 years.

19 Sec. 459. **(1)** ~~Transporting female for prostitution~~ ~~Any~~ **A**  
 20 person who ~~shall knowingly transport~~ **TRANSPORTS** or ~~cause~~ **CAUSES** to  
 21 be transported, or ~~aid~~ **AIDS** or ~~assist~~ **ASSISTS** in obtaining  
 22 transportation for, by any means of conveyance, into, through or  
 23 across this state, any ~~female~~ person for the purpose of  
 24 prostitution or with the intent and purpose to induce, entice or  
 25 compel ~~such female~~ **THAT** person to become a prostitute ~~shall be~~ **IS**  
 26 guilty of a felony, punishable by imprisonment ~~in the state prison~~  
 27 for not more than 20 years. ~~, any~~

1       (2) A person who ~~may commit the crime in~~ **VIOLATES** this section  
2 ~~mentioned~~ may be prosecuted, indicted, tried, and convicted in any  
3 county or city in or through which he shall ~~so~~ transport or attempt  
4 to transport any ~~female person as aforesaid~~. **IN VIOLATION OF THIS**  
5 **SECTION.**

6       Sec. 460. (1) ~~Acts committed outside state It shall~~ **IT IS** not  
7 ~~be a defense to a prosecution for any of the acts prohibited in the~~  
8 ~~next 5 preceding sections~~ **A VIOLATION** of this chapter that any part  
9 of ~~such act or acts shall have been~~ **THAT VIOLATION WAS** committed  
10 outside this state. ~~, and the offense shall in such case be deemed~~  
11 ~~and alleged to have been committed and the offender~~

12       (2) **A PERSON WHO VIOLATES THIS CHAPTER MAY BE** tried and  
13 punished in any county in which the prostitution was intended to be  
14 practiced, or in which the offense was consummated, or **IN WHICH** any  
15 overt act in furtherance of the offense ~~shall have been~~ **WAS**  
16 committed.
