SUBSTITUTE FOR HOUSE BILL NO. 4204

A bill to amend 2001 PA 142, entitled "Michigan memorial highway act,"

(MCL 250.1001 to 250.2080) by adding sections 2a and 76.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2A. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), ALL OF THE
- 2 FOLLOWING APPLY TO A STATE TRUNK LINE HIGHWAY OR A PORTION OF A
- 3 STATE TRUNK LINE HIGHWAY NAMED UNDER THIS ACT:
- 4 (A) AT ANY TIME, A STATE TRUNK LINE HIGHWAY OR PORTION OF A
- 5 STATE TRUNK LINE HIGHWAY SHALL NOT HAVE MORE THAN 1 NAME ASSIGNED
- 6 UNDER THIS ACT.
- 7 (B) THE NAME OF A HIGHWAY OR A PORTION OF A HIGHWAY NAMED
- 8 UNDER THIS ACT SHALL BE IN EFFECT FOR NO LONGER THAN 50 YEARS.
- 9 (C) EXCEPT AS OTHERWISE PROVIDED IN SUBDIVISION (D), A STATE

- 1 TRUNK LINE HIGHWAY OR PORTION OF A STATE TRUNK LINE HIGHWAY SHALL
- 2 BE NAMED ONLY AFTER 1 OF THE FOLLOWING:
- 3 (i) A DECEASED INDIVIDUAL WHO WAS 1 OR MORE OF THE FOLLOWING:
- 4 (A) A MEMBER OF THE UNITED STATES ARMY, AIR FORCE, NAVY,
- 5 MARINE CORPS, OR COAST GUARD WHO DIED IN THE LINE OF DUTY.
- 6 (B) AN OFFICER EMPLOYED BY THE DEPARTMENT OF STATE POLICE WHO
- 7 DIED IN THE LINE OF DUTY. AS USED IN THIS SUB-SUBPARAGRAPH,
- 8 "OFFICER" MEANS THAT TERM AS DEFINED IN SECTION 1 OF 1935 PA 59,
- 9 MCL 28.1.
- 10 (C) A FIRST RESPONDER WHO DIED IN THE LINE OF DUTY ON A STATE
- 11 TRUNK LINE HIGHWAY. FIRST RESPONDER INCLUDES A POLICE OFFICER.
- 12 (D) AN INDIVIDUAL WHO WAS BORN OR RESIDED IN THIS STATE AND
- 13 WHO WAS OF STATEWIDE SIGNIFICANCE, IF THE STATE TRUNK LINE HIGHWAY
- 14 OR PORTION OF THE STATE TRUNK LINE HIGHWAY IS NAMED UNDER THIS ACT
- 15 WITHIN 5 YEARS AFTER THAT INDIVIDUAL'S DEATH.
- 16 (ii) AN EVENT OR AN ORGANIZATION THAT IS OF STATEWIDE
- 17 SIGNIFICANCE.
- 18 (D) A PORTION OF A STATE TRUNK LINE HIGHWAY THAT IS LOCATED
- 19 WITHIN THE JURISDICTIONAL LIMITS OF A CITY OR VILLAGE SHALL BE
- 20 NAMED ONLY AFTER A DECEASED INDIVIDUAL WHO WAS 1 OR BOTH OF THE
- 21 FOLLOWING:
- 22 (i) A LOCAL POLICE OFFICER OR A FIRST RESPONDER WHO DIED IN THE
- 23 LINE OF DUTY.
- 24 (ii) AN INDIVIDUAL WHO WAS BORN OR RESIDED IN THE CITY OR
- 25 VILLAGE AND WHO WAS OF SIGNIFICANCE TO THE CITY OR VILLAGE, IF THE
- 26 STATE TRUNK LINE HIGHWAY OR PORTION OF THE STATE TRUNK LINE HIGHWAY
- 27 IS NAMED UNDER THIS ACT WITHIN 5 YEARS AFTER THAT INDIVIDUAL'S

- 1 DEATH.
- 2 (2) THIS SECTION DOES NOT APPLY TO A STATE TRUNK LINE HIGHWAY
- OR PORTION OF A STATE TRUNK LINE HIGHWAY THAT WAS NAMED UNDER THIS 3
- ACT BEFORE THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS
- 5 SECTION.
- SEC. 76. THE PORTION OF HIGHWAY M-71 THAT IS WITHIN THE 6
- 7 VILLAGE LIMITS OF THE VILLAGE OF VERNON SHALL BE KNOWN AS THE
- 8 "GRAHAM BARLOW JR., WWII MEMORIAL HIGHWAY".
