

**SUBSTITUTE FOR  
HOUSE BILL NO. 4208**

A bill to amend 1986 PA 59, entitled  
"Resort district rehabilitation act,"  
by amending sections 2 and 6 (MCL 125.2202 and 125.2206).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 2. As used in this act:

2       (a) "Authority" means a resort district authority created  
3 pursuant to this act.

4       (b) "Board" means the governing body of an authority.

5       (c) "Operation" means office maintenance, including salaries  
6 and expenses of employees, office supplies, consultation fees,  
7 design costs, and other expenses incurred in the daily management  
8 of the authority and planning of its activities.

9       (d) "Rehabilitation" means construction, reconstruction,  
10 repair, or maintenance of a road, street lighting, a sanitary

1 sewer, a storm sewer, storm water drainage **FACILITIES**, or a flood  
 2 control project within a resort district, or establishment and  
 3 operation of a system of garbage collection within the resort  
 4 district.

5 (e) "Rehabilitation plan" means ~~the information and~~  
 6 ~~requirements set forth~~ **A PLAN AS DESCRIBED** in section 15.

7 (f) "Resort district" means an area ~~which~~ **THAT** encompasses a  
 8 natural geographic feature used for recreation, such as an inland  
 9 lake or the Great Lakes shoreline, ~~which~~ **THAT** is specifically  
 10 designated by resolution and approved as provided in this act, and  
 11 a portion of which ~~area~~ is land that is or was a part of a resort  
 12 association incorporated under 1 of the following:

25 Sec. 6. (1) The authority shall be under the supervision and  
 26 control of a board. ~~consisting~~ **THE BOARD SHALL CONSIST** of 2 elected  
 27 officials of the township, 2 residents of ~~an area that is or was a~~

1 ~~resort association as described in section 2(f),~~ **THE RESORT**  
2 **DISTRICT**, and 1 individual designated by the industrial or  
3 commercial facility, located within the township, ~~which~~**THAT** has  
4 the highest state equalized valuation as of December 31 of the year  
5 preceding the year of the designation. The board members shall be  
6 appointed or designated within 30 days after adoption of the  
7 ordinance or resolution under section 5.

8 (2) A member shall be appointed by the township supervisor  
9 subject to approval by the township board. Of the 2 resident  
10 members first appointed, 1 shall be appointed for a term expiring  
11 December 31 of the year after the year of appointment and 1 for a  
12 term expiring December 31 of the third year after the year of  
13 appointment. Thereafter, each resident member shall serve for a  
14 term of 4 years. A member shall hold office until the member's  
15 successor is appointed. An appointment to fill a vacancy shall be  
16 made by the township supervisor for the unexpired term.

17 (3) If approved by the township board, a board member shall  
18 receive compensation limited to a reasonable per diem which shall  
19 include actual and necessary expenses.

20 (4) The chairperson of the board shall be elected by the board  
21 from among its members. Before assuming the duties of office, a  
22 board member shall qualify by taking and subscribing to the  
23 constitutional oath of office provided in section 1 of article XI  
24 of the state constitution of 1963.
