SUBSTITUTE FOR HOUSE BILL NO. 4878

A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending section 5090 (MCL 168.5090), as added by 1994 PA 441, and by adding section 645a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5090. (1) The secretary of state shall direct and
- 2 supervise the establishment and maintenance of a statewide
- 3 qualified voter file. The secretary of state shall establish the
- 4 technology to implement the qualified voter file on or before
- 5 January 1, 1997. The qualified voter file shall be the official
- 6 file for the conduct of all elections held in this state on or
- 7 after January 1, 1998. The secretary of state may direct that all
- 8 or any part of the city , OR township , or village registration

- 1 files shall be used in conjunction with the qualified voter file at
- 2 the first state primary and election held after the creation of the
- 3 qualified voter file.
- 4 (2) Notwithstanding any other provision of law to the
- 5 contrary, beginning January 1, 1998, a person who appears to vote
- 6 in an election and whose name appears in the qualified voter file
- 7 for that city ,—OR township , village, or school district—is
- 8 considered a registered voter of that city -OR township village.
- 9 or school district under this act.
- 10 (3) The secretary of state, a designated voter registration
- 11 agency, or a county, city —OR township —or village—clerk shall
- 12 not place a name of an individual into the qualified voter file
- 13 unless that person signs an application as prescribed in section
- 14 509r(3). The secretary of state or a designated voter registration
- 15 agency shall not allow a person to indicate a different address
- 16 than the address in either the secretary of state's or designated
- 17 voter registration agency's files to be placed in the qualified
- 18 voter file.
- 19 (4) BEGINNING JANUARY 1, 2014, THE BUREAU OF ELECTIONS OR A

- 25 UNLESS APPROVED BY RESOLUTION OF THE GOVERNING BODY OF THE

- 27 SEC. 645A. (1) NOTWITHSTANDING ANY PROVISION OF LAW TO THE

- 11 FILE, INCLUDING, BUT NOT LIMITED TO, MAINTAINING THE STREET INDEX.
- 12 (2) NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, THE
- 13 CLERK OF A CITY OR TOWNSHIP MAY ENTER INTO A WRITTEN AGREEMENT WITH
- 14 ANOTHER CLERK OF A CITY OR TOWNSHIP TO CONDUCT CERTAIN ELECTION
- 15 ADMINISTRATION DUTIES FOR THE CITY OR TOWNSHIP, INCLUDING, BUT NOT
- 16 LIMITED TO, ANY OF THE FOLLOWING:
- 17 (A) DISTRIBUTING, RECEIVING, AND PROCESSING ABSENT VOTER
- 18 BALLOT APPLICATIONS AND ABSENT VOTER BALLOTS.
- 19 (B) PROCESSING VOTER REGISTRATIONS IN THE QUALIFIED VOTER
- 20 FILE.
- 21 (C) CONDUCTING REGULAR LIST MAINTENANCE OF THE QUALIFIED VOTER
- 22 FILE, INCLUDING, BUT NOT LIMITED TO, MAINTAINING THE STREET INDEX.
- 23 (D) PREPARING FOR AND CONDUCTING ELECTION DAY OPERATIONS.
- 24 (3) A WRITTEN AGREEMENT ENTERED INTO UNDER SUBSECTION (1) OR
- 25 (2) IS NOT EFFECTIVE UNLESS APPROVED BY RESOLUTION OF THE GOVERNING
- 26 BODY OF EACH PARTICIPATING COUNTY, CITY, OR TOWNSHIP.
- 27 (4) IF THE OFFICE OF COUNTY, CITY, OR TOWNSHIP CLERK BECOMES

- VACANT IN CLOSE PROXIMITY TO AN ELECTION, THE BUREAU OF ELECTIONS 1
- 2 OR A COUNTY, CITY, OR TOWNSHIP CLERK MAY, WITH THE APPROVAL OF THE
- GOVERNING BODY OF THE COUNTY, CITY, OR TOWNSHIP WHERE THE VACANCY 3
- 4 OCCURS, SUPERVISE OR ADMINISTER THE UPCOMING ELECTION.
- 5 (5) THE BUREAU OF ELECTIONS SHALL DEVELOP MODEL LANGUAGE TO BE
- 6 USED BY A COUNTY, CITY, OR TOWNSHIP FOR WRITTEN AGREEMENTS ENTERED
- 7 INTO UNDER THIS SECTION.
- (6) A WRITTEN AGREEMENT ENTERED INTO UNDER THIS SECTION SHALL 8
- CONTAIN A PROVISION THAT EITHER PARTICIPATING PARTY SUBJECT TO THE
- 10 WRITTEN AGREEMENT MAY TERMINATE THAT WRITTEN AGREEMENT WITH 60
- 11 DAYS' WRITTEN NOTICE TO THE OTHER PARTICIPATING PARTY.
- 12 (7) A WRITTEN AGREEMENT ENTERED INTO UNDER THIS SECTION SHALL
- BE FILED WITH THE BUREAU OF ELECTIONS AND WITH THE CLERK OF EACH 13
- 14 COUNTY WHERE A PARTICIPATING PARTY IS LOCATED. IN ADDITION, THE
- WRITTEN NOTICE TO TERMINATE A WRITTEN AGREEMENT ENTERED INTO UNDER 15
- THIS SECTION SHALL BE FILED WITH THE BUREAU OF ELECTIONS AND WITH 16
- 17 THE CLERK OF EACH COUNTY WHERE A PARTICIPATING PARTY IS LOCATED.
