## SENATE SUBSTITUTE FOR HOUSE BILL NO. 4890

A bill to amend 1968 PA 251, entitled "Cemetery regulation act,"

(MCL 456.521 to 456.543) by amending the title and by adding section 17.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE 2 An act to regulate the creation and management of cemeteries; 3 to provide for a cemetery commissioner and to prescribe the powers and duties of the commissioner; to require the registration and 4 5 audit of cemeteries; to provide standards regarding the long-term 6 care of certain cemeteries and trusting of certain funds; to regulate persons selling burial, entombment, or columbarium rights 7 8 and certain merchandise; to provide for qualifications for owners,

- 2 circumstances; TO PROVIDE FOR THE ABANDONMENT OF INTERMENT RIGHTS;
- 3 to allow the cemetery commissioner to conduct certain
- 4 investigations; and to prescribe administrative and civil remedies
- 5 and penalties.
- 6 SEC. 17. (1) A PERSON POSSESSING A RIGHT TO A SPACE WITHIN A
- 7 CEMETERY IS PRESUMED TO HAVE ABANDONED THE RIGHT IF ALL OF THE
- 8 FOLLOWING APPLY:
- 9 (A) DURING THE PAST 60 YEARS, THE PERSON POSSESSING THE RIGHT
- 10 TO THE SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT
- 11 PROVIDED THE CEMETERY OWNER OR OPERATOR WITH AN UPDATED ADDRESS FOR
- 12 PURPOSES OF CONTACTING THE PERSON.
- 13 (B) DURING THE PAST 60 YEARS, THE PERSON POSSESSING THE RIGHT
- 14 TO THE SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT
- 15 CONTACTED THE CEMETERY OWNER OR OPERATOR AND AFFIRMED POSSESSION OF
- 16 THE RIGHT IN ANY OF THE FOLLOWING WAYS:
- 17 (i) REQUESTING AN INTERMENT OR NOTIFYING THE CEMETERY OWNER OR
- 18 OPERATOR OF AN INTERMENT UNDER THE RIGHT TO THE SPACE.
- 19 (ii) REQUESTING THE INSTALLATION OF A MEMORIAL OR NOTIFYING THE
- 20 CEMETERY OWNER OR OPERATOR OF THE INSTALLATION OF A MEMORIAL UNDER
- 21 THE RIGHT TO THE SPACE.
- 22 (iii) INDICATING OR REQUESTING A TRANSFER OF THE RIGHT TO THE
- 23 SPACE TO ANOTHER PERSON.
- 24 (iv) MAKING A PAYMENT TO THE CEMETERY OWNER OR OPERATOR
- 25 RELATING TO THE RIGHT TO THE SPACE.
- 26 (v) AFFIRMING IN WRITING THE POSSESSION OF THE RIGHT TO THE
- 27 SPACE.

- 1 (C) A MEMORIAL HAS NOT BEEN INSTALLED AT THE CEMETERY UNDER
- 2 THE RIGHT TO THE SPACE.
- 3 (D) REMAINS HAVE NOT BEEN INTERRED AT THE CEMETERY UNDER THE
- 4 RIGHT TO THE SPACE.
- 5 (2) IF, AFTER A RIGHT TO A SPACE IS PRESUMED TO BE ABANDONED
- 6 UNDER SUBSECTION (1), ALL OF THE FOLLOWING REQUIREMENTS ARE MET,
- 7 THE CEMETERY OWNER OR OPERATOR MAY UNDER SUBSECTION (4) CERTIFY THE
- 8 RIGHT AS ABANDONED:
- 9 (A) THE CEMETERY OWNER OR OPERATOR POSTS ON THE SPACE FOR 120
- 10 CONSECUTIVE DAYS A WRITTEN NOTICE OF INTENT TO CERTIFY THE RIGHT TO
- 11 THE SPACE AS ABANDONED.
- 12 (B) IF THE CEMETERY OWNER OR OPERATOR HAS A MAILING ADDRESS
- 13 FOR THE PERSON POSSESSING THE RIGHT TO THE SPACE OR THE PERSON'S
- 14 AUTHORIZED REPRESENTATIVE, THE CEMETERY OWNER OR OPERATOR SENDS TO
- 15 THAT ADDRESS A WRITTEN NOTICE OF INTENT TO CERTIFY THE RIGHT TO THE
- 16 SPACE AS ABANDONED. THE NOTICE SHALL BE SENT BY CERTIFIED MAIL WITH
- 17 A RETURN RECEIPT REQUESTED.
- 18 (C) IF ANY OF THE FOLLOWING CONDITIONS APPLY, THE CEMETERY
- 19 OWNER OR OPERATOR PUBLISHES ONCE A WEEK FOR 2 CONSECUTIVE WEEKS A
- 20 NOTICE OF INTENT TO CERTIFY THE RIGHT TO THE SPACE AS ABANDONED IN
- 21 A NEWSPAPER CIRCULATED IN THE COUNTY IN WHICH THE CEMETERY IS
- 22 LOCATED:
- 23 (i) THE CEMETERY OWNER OR OPERATOR DOES NOT HAVE A MAILING
- 24 ADDRESS FOR THE PERSON POSSESSING THE RIGHT TO THE SPACE OR THE
- 25 PERSON'S AUTHORIZED REPRESENTATIVE.
- 26 (ii) WHETHER OR NOT A WRITTEN NOTICE MAILED UNDER SUBDIVISION
- 27 (B) IS RETURNED AS UNDELIVERABLE, THE PERSON POSSESSING THE RIGHT

- 1 TO THE SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT
- 2 CONTACTED THE CEMETERY OWNER OR OPERATOR AND AFFIRMED THE PERSON'S
- 3 POSSESSION OF THE RIGHT WITHIN 60 DAYS AFTER THE NOTICE WAS MAILED.
- 4 (D) IF PUBLICATION IS REQUIRED UNDER SUBDIVISION (C), 60 DAYS
- 5 HAVE ELAPSED SINCE THE CEMETERY OWNER OR OPERATOR PUBLISHED THE
- 6 SECOND NOTICE AND THE PERSON POSSESSING THE RIGHT TO THE SPACE OR
- 7 THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT CONTACTED THE
- 8 CEMETERY OWNER OR OPERATOR AND AFFIRMED THE PERSON'S POSSESSION OF
- 9 THE RIGHT.
- 10 (3) A NOTICE REQUIRED UNDER SUBSECTION (2) SHALL STATE ALL OF
- 11 THE FOLLOWING:
- 12 (A) A DESCRIPTION OF THE RIGHT TO A SPACE AFFECTED.
- 13 (B) IF KNOWN TO THE CEMETERY OWNER OR OPERATOR, THE NAME OF
- 14 THE PERSON POSSESSING THE RIGHT TO THE SPACE AND THE PERSON'S
- 15 AUTHORIZED REPRESENTATIVE, IF ANY.
- 16 (C) THE TIME FRAME WITHIN WHICH A PERSON POSSESSING THE RIGHT
- 17 TO THE SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE MUST CONTACT
- 18 THE CEMETERY OWNER OR OPERATOR AND AFFIRM THE PERSON'S POSSESSION
- 19 OF THE RIGHT TO THE SPACE TO PREVENT THE RIGHT FROM BEING CERTIFIED
- 20 AS ABANDONED.
- 21 (D) THAT, IF THE RIGHT TO THE SPACE IS CERTIFIED AS ABANDONED,
- 22 A PERSON WHO POSSESSED THE RIGHT MAY BE ENTITLED TO THE REMEDIES
- 23 SET FORTH IN SECTION 17 OF THE CEMETERY REGULATION ACT, 1968 PA
- 24 251, MCL 456.537.
- 25 (E) THE NAME, ADDRESS, ELECTRONIC MAIL ADDRESS, AND TELEPHONE
- 26 NUMBER OF THE CEMETERY OWNER OR OPERATOR.
- 27 (4) A RIGHT TO A SPACE IS CERTIFIED AS ABANDONED BY ANY PERSON

- 1 POSSESSING THE RIGHT IF, AFTER SATISFYING THE REQUIREMENTS OF
- 2 SUBSECTIONS (2) AND (3), THE CEMETERY OWNER OR OPERATOR CREATES,
- 3 SIGNS, AND MAINTAINS A RECORD THAT STATES ALL OF THE FOLLOWING:
- 4 (A) A DESCRIPTION OF THE RIGHT TO A SPACE AFFECTED.
- 5 (B) THE NAMES OF ANY PERSONS POSSESSING THE RIGHT TO THE SPACE
- 6 IMMEDIATELY BEFORE THE RIGHT IS CERTIFIED AS ABANDONED, IF KNOWN TO
- 7 THE CEMETERY OWNER OR OPERATOR.
- 8 (C) THAT THE RIGHT TO THE SPACE IS PRESUMED TO BE ABANDONED
- 9 UNDER THE CRITERIA SET FORTH IN SUBSECTION (1).
- 10 (D) THAT THE CEMETERY OWNER OR OPERATOR PROVIDED NOTICE IN
- 11 COMPLIANCE WITH SUBSECTIONS (2) AND (3).
- 12 (E) THAT THE CEMETERY OWNER OR OPERATOR HAS NOT RECEIVED A
- 13 RESPONSE TO A NOTICE UNDER SUBSECTION (2) FROM A PERSON POSSESSING
- 14 THE RIGHT TO THE SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE
- 15 AFFIRMING THE PERSON'S POSSESSION OF THE RIGHT.
- 16 (5) A PERSON WHOSE RIGHT TO A SPACE WAS CERTIFIED AS ABANDONED
- 17 UNDER SUBSECTION (4) IS ENTITLED ONLY TO THE FOLLOWING REMEDIES:
- 18 (A) REINSTATEMENT OF THE RIGHT TO THE SPACE IF THE RIGHT HAS
- 19 NOT BEEN RESOLD OR OTHERWISE TRANSFERRED TO ANOTHER PERSON BY THE
- 20 CEMETERY OWNER OR OPERATOR.
- 21 (B) IF THE RIGHT TO THE SPACE HAS BEEN RESOLD OR OTHERWISE
- 22 TRANSFERRED TO ANOTHER PERSON BY THE CEMETERY OWNER OR OPERATOR, AT
- 23 THE OPTION OF THE PERSON WHOSE RIGHT WAS CERTIFIED AS ABANDONED,
- 24 EITHER OF THE FOLLOWING:
- 25 (i) A DIFFERENT RIGHT TO A SPACE OF COMPARABLE VALUE WITHIN THE
- 26 CEMETERY.
- 27 (ii) COMPENSATION IN THE AMOUNT THAT THE PERSON WHOSE RIGHT WAS

- 1 CERTIFIED AS ABANDONED PAID FOR THE RIGHT OR IN AN AMOUNT EQUAL TO
- 2 65% OF THE PRICE FOR WHICH THE RIGHT WAS RESOLD OR OTHERWISE
- 3 TRANSFERRED BY THE CEMETERY OWNER OR OPERATOR, WHICHEVER AMOUNT IS
- 4 GREATER.
- 5 (6) IF A PERSON POSSESSING A RIGHT TO A SPACE WITHIN A
- 6 CEMETERY OR THE PERSON'S AUTHORIZED REPRESENTATIVE IS NOTIFIED BY
- 7 THE CEMETERY OWNER OR OPERATOR UNDER SUBSECTION (2) AND THE PERSON
- 8 OR THE PERSON'S AUTHORIZED REPRESENTATIVE DOES NOT WISH TO RETAIN
- 9 POSSESSION OF THE RIGHT, THE PERSON OR THE PERSON'S AUTHORIZED
- 10 REPRESENTATIVE MAY TRANSFER THE RIGHT TO THE SPACE BACK TO THE
- 11 CEMETERY OWNER OR OPERATOR FOR AN AMOUNT AS AGREED BY THE PARTIES.
- 12 (7) A CONTRACT FOR THE SALE OF A RIGHT TO A SPACE ENTERED INTO
- 13 BY A CEMETERY OWNER OR OPERATOR AFTER THE EFFECTIVE DATE OF THIS
- 14 SECTION SHALL CONTAIN A WRITTEN NOTICE OF THE PRESUMPTION OF
- 15 ABANDONMENT OF A RIGHT TO A SPACE UNDER SUBSECTION (1).
- 16 (8) A CEMETERY OWNER OR OPERATOR MAY PUBLISH ON 1 OR MORE
- 17 INTERNET WEBSITES A NOTICE OF INTENT TO CERTIFY A RIGHT TO A SPACE
- 18 AS ABANDONED UNDER SUBSECTION (2). A CEMETERY OWNER MAY USE AN
- 19 INTERNET SEARCH TO ATTEMPT TO IDENTIFY FOR USE UNDER SUBSECTION (2)
- 20 THE CURRENT MAILING ADDRESS OF A PERSON POSSESSING A RIGHT TO A
- 21 SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE.
- 22 (9) SUBSECTIONS (1) TO (8) DO NOT APPLY TO A RIGHT TO A SPACE
- 23 IF 1 OR MORE OF THE FOLLOWING APPLY:
- 24 (A) AN INSCRIBED MEMORIAL IS LOCATED ON THE SPACE TO WHICH THE
- 25 RIGHT APPLIES.
- 26 (B) BOTH OF THE FOLLOWING APPLY TO THE SPACE TO WHICH THE
- 27 RIGHT APPLIES:

- 1 (i) THE SPACE IMMEDIATELY ADJOINS AN INSCRIBED MEMORIAL AND THE
- 2 ADJOINING SIDE OF THE INSCRIBED MEMORIAL DISPLAYS A FAMILY SURNAME.
- 3 (ii) THE SPACE WAS PURCHASED WITH ANOTHER SPACE ON WHICH THE
- 4 INSCRIBED MEMORIAL THAT DISPLAYS THE FAMILY SURNAME IS LOCATED.
- 5 (C) BOTH OF THE FOLLOWING APPLY TO THE SPACE TO WHICH THE
- 6 RIGHT APPLIES:
- 7 (i) THE SPACE IMMEDIATELY ADJOINS AN INSCRIBED MEMORIAL.
- 8 (ii) THE SPACE IMMEDIATELY ADJOINS A SPACE THAT WAS PURCHASED
- 9 WITH THE RIGHT TO A SPACE AND INCLUDES INTERRED REMAINS.
- 10 (10) THIS SECTION IS INTENDED TO ADVANCE THE SIGNIFICANT AND
- 11 LEGITIMATE PUBLIC PURPOSE OF ENSURING THE AVAILABILITY AND
- 12 PRODUCTIVE USE OF SPACE WITHIN CEMETERIES AND PROVIDING SECURITY IN
- 13 RIGHTS CONSISTENT WITH THE HEALTH, SAFETY, AND WELFARE OF THE
- 14 PEOPLE OF THIS STATE.
- 15 (11) AS USED IN THIS SECTION:
- 16 (A) "INSCRIBED MEMORIAL" MEANS 1 OR BOTH OF THE FOLLOWING:
- 17 (i) A STONE OR OTHER STRUCTURE OR ITEM THAT IS USED FOR THE
- 18 PURPOSE OF MEMORIALIZING A DECEDENT ON A PLACE OF INTERMENT AND
- 19 THAT DISPLAYS THE NAME OF A DECEDENT.
- 20 (ii) A STONE OR OTHER STRUCTURE OR ITEM THAT IDENTIFIES AN AREA
- 21 OF A CEMETERY DEDICATED FOR THE INTERMENT OF MEMBERS OF A FAMILY
- 22 AND THAT DISPLAYS A FAMILY SURNAME.
- 23 (B) "RIGHT TO A SPACE" OR "RIGHT" MEANS THE PRIVILEGE,
- 24 LICENSE, OR RIGHT OF INTERMENT IN A SPACE IN A CEMETERY.
- 25 Enacting section 1. This amendatory act takes effect January
- **26** 1, 2015.
