THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 411w. (1) A person shall not knowingly sell, purchase, install, transfer, or possess in this state any automated sales suppression device or zapper, or phantom-ware, OR A SKIMMING
 - (2) A person who violates subsection (1) is guilty of a felony and shall be imprisoned for not less than 1 year or more than 5 years and, in addition, may be fined not more than \$100,000.00.
 - (3) A person who violates subsection (1) is liable for all taxes and penalties due the state as the result of the fraudulent use of an automated sales suppression device, or phantom-ware, OR A

- 17 (H) (e)—"Transaction report" means a report that includes, but
- 18 need not be limited to, the sales, taxes collected, media totals,
- 19 and discount voids at an electronic cash register that is printed
- 20 on cash register tape at the end of a day or shift, or a report
- 21 documenting every action at an electronic cash register that is
- 22 stored electronically.
