## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 6. (1) "Original member" means a member employed in
  Michigan public schools before July 1, 1945.
- 3 (2) "Out of system public education service" means service
  4 performed in public education meeting 1 or more of the following
  5 requirements:
  - (a) Performed in other states in the United States or its territorial possessions.
  - (b) Performed at the university of Michigan, Michigan state university, Wayne state university, Grand Valley state university, Oakland university, or Saginaw Valley university.

- 1 MCL 38.1 to 38.69, for service is paid to the retirement system.
- 2 Service at Ferris state university shall be creditable as prior
- 3 service or membership service only if the employee was employed at
- 4 Ferris state university on a full-time basis for 2 or more years
- 5 after May 17, 1949. Until January 1, 1988, public school employee
- 6 also includes an individual holding a Michigan teacher certificate
- 7 and serving as an employee of the Michigan high school athletic
- 8 association, other than a person whose effective date of employment
- 9 with the Michigan high school athletic association is on or after
- 10 December 31, 1986. Public school employee includes a public school
- 11 employee on an approved leave of absence that does not exceed 2
- 12 years from the date the employee ceases to accumulate service
- 13 credit. Public school employee does not include an individual who

- on or after January 1, 1996, or an employee who is hired but has
