- 3 INSURED MEMBER OF A PRIVATE EMPLOYER GROUP SELF-INSURER TERMINATES
- 4 ON JANUARY 1, [2020]. THE PEGSISF IS RESPONSIBLE FOR PAYMENT OF
- ELIGIBLE CLAIMS MADE AGAINST THE PEGSISF ON AND AFTER JANUARY 1,
- 5 [2020], AND FOR CLAIMS AGAINST A PRIVATE EMPLOYER GROUP SELF-INSURER
