A bill to amend 2003 PA 215, entitled "Credit union act,"

(MCL 490.101 to 490.601) by adding section 413.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 413. (1) A DOMESTIC CREDIT UNION THAT OWNS, OPERATES, OR
- 2 MANAGES AN AUTOMATED TELLER MACHINE LOCATED ON THE PREMISES OF A
- 3 CASINO, CASINO ENTERPRISE, LIQUOR STORE, OR ADULT ENTERTAINMENT
- 4 ESTABLISHMENT SHALL WORK WITH THE DEPARTMENT OF HUMAN SERVICES TO
- 5 ENSURE THAT THE AUTOMATED TELLER MACHINE DOES NOT ALLOW AN
- 6 INDIVIDUAL ACCESS TO CASH BENEFITS FROM A MICHIGAN BRIDGE CARD.
- 7 (2) AS USED IN THIS SECTION:
- 8 (A) "ADULT ENTERTAINMENT ESTABLISHMENT" MEANS ANY OF THE
- 9 FOLLOWING:
- 10 (i) AN ON-PREMISES LICENSEE THAT HOLDS A TOPLESS ACTIVITY

- 19 436.1111, THAT IS EXCLUSIVELY OR PRIMARILY ENGAGED IN THE SALE OF

- 23 (G) "MICHIGAN BRIDGE CARD" MEANS THE CARD THAT IS USED TO
- 24 DISTRIBUTE CASH BENEFITS BY THE DEPARTMENT OF HUMAN SERVICES.
- 25 <<(H) "RETAIL FOOD STORE" MEANS THAT TERM AS DEFINED IN 7 USC
- 26 (3) AS USED IN THIS SECTION, THE TERMS CASINO AND CASINO
- 27 ENTERPRISE DO NOT INCLUDE ANY OF THE FOLLOWING:

- 1 (A) A GROCERY STORE THAT SELLS GROCERIES, INCLUDING STAPLE
- 2 FOODS, AND IS LOCATED IN A CASINO OR A CASINO ENTERPRISE.
- 3 (B) ANY OTHER BUSINESS ESTABLISHMENT THAT OFFERS GAMING THAT
- IS INCIDENTAL TO THE PRINCIPAL PURPOSE OF THAT ESTABLISHMENT.

- 1, 2014.
