## SENATE BILL NO. 341

A bill to amend 2002 PA 712, entitled "Michigan Amber alert act," (MCL 28.751 to 28.754) by amending the title, as amended by 2005 PA

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

205, and by adding section 5.

- 2 An act to prescribe the Amber alert of Michigan as the
- 3 official response to reports of child abductions; to prohibit
- 4 certain conduct; TO CREATE THE MICHIGAN AMBER ALERT FUND; TO
- 5 PROVIDE FOR THE DISTRIBUTION OF THE MONEY FROM THE MICHIGAN AMBER
- 6 ALERT FUND; TO PROVIDE FOR APPROPRIATIONS; and to prescribe
- 7 penalties.
- 8 SEC. 5. (1) THE MICHIGAN AMBER ALERT FUND IS CREATED IN THE
- 9 DEPARTMENT TO PROVIDE FUNDS FOR THE MAINTENANCE, OPERATION, AND

- 1 ADMINISTRATION OF THE MICHIGAN AMBER ALERT PLAN. THE DEPARTMENT
- 2 SHALL BE THE ADMINISTRATOR OF THE FUND FOR AUDITING PURPOSES.
- 3 (2) THE STATE TREASURER SHALL CREDIT TO THE FUND ALL AMOUNTS
- 4 APPROPRIATED FOR THIS PURPOSE UNDER SECTION 435 OF THE INCOME TAX
- 5 ACT OF 1967, 1967 PA 281, MCL 206.435, AND MONEY FROM ANY OTHER
- 6 SOURCE FOR DEPOSIT INTO THE FUND.
- 7 (3) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 8 FUND. THE FUND SHALL CONSIST OF THE MONEY CREDITED TO THE FUND
- 9 PURSUANT TO SECTION 435 OF THE INCOME TAX ACT OF 1967, 1967 PA 281,
- 10 MCL 206.435, ANY INTEREST AND EARNINGS ACCRUING FROM THE SAVING AND
- 11 INVESTMENT OF THAT MONEY, AND MONEY FROM ANY OTHER SOURCE.
- 12 (4) MONEY IN THE FUND AT THE CLOSE OF THE YEAR SHALL REMAIN IN
- 13 THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 14 (5) THE MONEY, INTEREST, AND EARNINGS OF THE FUND SHALL BE
- 15 EXPENDED SOLELY FOR THE PURPOSES DESCRIBED IN THIS ACT. THE MONEY
- 16 IN THE FUND THAT IS AVAILABLE FOR DISTRIBUTION SHALL BE
- 17 APPROPRIATED EACH YEAR. MONEY GRANTED OR RECEIVED AS A GIFT OR
- 18 DONATION TO THE FUND IS AVAILABLE FOR DISTRIBUTION UPON
- 19 APPROPRIATION.
- 20 (6) AS USED IN THIS SECTION:
- 21 (A) "DEPARTMENT" MEANS THE DEPARTMENT OF STATE POLICE.
- 22 (B) "FUND" MEANS THE MICHIGAN AMBER ALERT FUND.
- 23 Enacting section 1. This amendatory act does not take effect
- 24 unless Senate Bill No. 342 of the 97th Legislature is enacted into
- 25 law.
