SUBSTITUTE FOR

SENATE BILL NO. 471

A bill to amend 1925 PA 289, entitled

"An act to create and maintain a fingerprint identification and criminal history records division within the department of state police; to require peace officers, persons in charge of certain institutions, and others to make reports respecting juvenile offenses, crimes, and criminals to the state police; to require the fingerprinting of an accused by certain persons; and to provide penalties and remedies for a violation of this act,"

by amending section 2a (MCL 28.242a), as amended by 2012 PA 374.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2a. (1) Except as provided in subsection (2), all ALL
- 2 criminal history record information that is associated with a state
- 3 identification number and is supported by biometric data shall be
- 4 disseminated in response to EITHER a fingerprint-based SEARCH or A
- 5 name-based search of the criminal history record information
- 6 database. THIS SUBSECTION DOES NOT ALLOW THE DISSEMINATION OF

- 1 CRIMINAL HISTORY RECORD INFORMATION THAT IS NONPUBLIC OR IS
- 2 PROHIBITED BY LAW FROM BEING DISSEMINATED.
- 3 (2) Subsection (1) does not require the dissemination of
- 4 criminal history record information that is nonpublic or is
- 5 prohibited by law from being disseminated.
- 6 (2) EXCEPT AS PROVIDED IN SUBSECTION (3), ALL JUVENILE HISTORY
- 7 RECORD INFORMATION THAT IS ASSOCIATED WITH A STATE IDENTIFICATION
- 8 NUMBER AND IS SUPPORTED BY BIOMETRIC DATA SHALL BE DISSEMINATED IN
- 9 RESPONSE ONLY TO A FINGERPRINT-BASED SEARCH OF THE CRIMINAL HISTORY
- 10 RECORD INFORMATION DATABASE. THIS SUBSECTION DOES NOT ALLOW THE
- 11 DISSEMINATION OF JUVENILE HISTORY RECORD INFORMATION THAT IS
- 12 NONPUBLIC OR IS PROHIBITED BY LAW FROM BEING DISSEMINATED.
- 13 (3) ALL JUVENILE HISTORY RECORD INFORMATION THAT IS ASSOCIATED
- 14 WITH A STATE IDENTIFICATION NUMBER AND THAT IS SUPPORTED BY
- 15 BIOMETRIC DATA SHALL BE DISSEMINATED IN RESPONSE TO EITHER A NAME-
- 16 BASED OR A FINGERPRINT-BASED SEARCH OF THE CRIMINAL HISTORY RECORD
- 17 INFORMATION DATABASE SOLELY TO A PERSON OR ENTITY AUTHORIZED TO
- 18 ACCESS THE LAW ENFORCEMENT INFORMATION NETWORK. THIS SUBSECTION
- 19 DOES NOT ALLOW THE DISSEMINATION OF JUVENILE HISTORY RECORD
- 20 INFORMATION THAT IS PROHIBITED BY LAW FROM BEING DISSEMINATED.
