A bill to amend 1986 PA 268, entitled "Legislative council act,"

by amending section 204a (MCL 4.1204a), as added by 1998 PA 429; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 204a. (1) Notwithstanding section 204, beginning January

  1, 2001, the council shall make, for the current legislative

  session, the legislative calendar, notices of legislative committee

  and subcommittee meetings, including the agendas, and a listing of

  the committees of each house and their members ALL OF THE FOLLOWING

  available to the public on the Internet. INTERNET:
  - (A) THE LEGISLATIVE CALENDAR, NOTICES OF LEGISLATIVE COMMITTEE
    AND SUBCOMMITTEE MEETINGS, INCLUDING THE AGENDAS, AND A LISTING OF
    THE COMMITTEES OF EACH HOUSE AND THEIR MEMBERS FOR THE CURRENT
