April 9, 2013, Introduced by Reps. Potvin, LaVoy, Cavanagh and Rendon and referred to the Committee on Government Operations.

A bill to amend 1945 PA 78, entitled "An act to declare the area of the state of Michigan," by amending the title and sections 1 and 2 (MCL 2.1 and 2.2).

Sec. 1. (1) The total area of the state of Michigan is hereby declared to be APPROXIMATELY 96,720 square miles consisting of 57,022 square miles of land and 39,698 square miles of inland water as based upon the boundaries of the state of Michigan according to article I, section 1 of the constitution of the state of Michigan of 1909, and United States statutes at large, volume 5, page 49,
