- 5 OTHER THAN A PHYSICIAN UNLESS THAT BENEFIT PLAN ALSO INCLUDES
- 6 COVERAGE FOR FIRST ASSISTANT AT SURGERY SERVICES RENDERED BY A
 - REGISTERED PROFESSIONAL NURSE WHO IS ACTING AS A REGISTERED NURSE
- FIRST ASSISTANT WITHIN THE SCOPE OF HIS OR HER LICENSE OR SPECIALTY
