

# HOUSE BILL No. 4525

April 10, 2013, Introduced by Rep. Graves and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending sections 16c and 17d of chapter XVII (MCL 777.16c and  
777.17d), section 16c as amended by 2012 PA 534 and section 17d  
as amended by 2012 PA 456.

### CHAPTER XVII

Sec. 16c. This chapter applies to the following felonies
