A bill to amend 1956 PA 217, entitled

"Electrical administrative act,"

by amending sections 6 and 7 (MCL 338.886 and 338.887), section 6 as amended by 1992 PA 130 and section 7 as amended by 2002 PA 205.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) This act, except as otherwise provided for in this
- 2 section, shall DOES not apply within the jurisdiction of a city,
- 3 village, or township which THAT ADOPTS OR has adopted or hereafter
- 4 adopts an ordinance providing THAT PROVIDES standards for the
- 5 examination and licensing of master electricians, electrical or
- 6 specialty contractors, electrical journeymen, sign specialists, and
- 7 fire alarm specialty technicians and the registration of apprentice
- **8** electricians and fire alarm specialty apprentice technicians which
- are not less than THAT ARE AT LEAST AS STRINGENT AS those

- 1 prescribed by this act; providing for enforcement that is
- 2 substantially similar to this act; providing for civil and criminal
- 3 penalties and a citation system for minor violations substantially
- 4 similar to section 8c; providing for the issuance of an
- 5 identification card that substantially complies with the
- 6 requirements imposed in section 8c; and providing for the
- 7 inspection of electrical wiring and equipment.
- 8 (2) This act shall not be construed as limiting the power of a
- 9 municipality to enact such—an ordinance DESCRIBED IN SUBSECTION
- 10 (1), to provide for the licensing of persons , firms, or
- 11 corporations as electrical or specialty contractors who THAT have a
- 12 place of business located in the municipality, or to provide for
- 13 the licensing of journeymen electricians, sign specialists, or fire
- 14 alarm specialty technicians who reside in the municipality except
- 15 that the ordinance shall not require either of the following:
- 16 (a) The procurement of a license or permit to execute the
- 17 classes of work specified in section $\frac{7(c)}{7(3)(0)}$, (d), (e), and
- 18 (f), OR (K).
- 19 (b) The procurement of public liability insurance in excess of
- 20 the coverage required by UNDER this act.
- 21 (3) Licenses or registrations A LICENSE OR REGISTRATION issued
- 22 by the board under this act and licenses issued by a municipality
- 23 having THAT HAVE standards for licensing not less than AT LEAST AS
- 24 STRINGENT AS those established by the board shall be recognized by
- 25 all municipalities.
- 26 (4) A municipality providing THAT PROVIDES for electrical
- 27 inspection by local ordinance may require all electrical or

- 1 specialty contractors, sign specialists, fire alarm specialty
- 2 technicians, and classes of electricians doing work in the
- 3 municipality to register in accordance with its local ordinance.
- 4 (5) Municipal registration requirements shall be reciprocal
- 5 between the municipalities and between municipalities and the board
- 6 as to registration requirements and fees, except that licensed
- 7 electrical journeymen, sign specialists, and fire alarm specialty
- 8 technicians shall ARE not be required to register to work in
- 9 municipalities under the jurisdiction of the board. All licenses
- 10 and registrations A MUNICIPALITY SHALL OFFICIALLY RECOGNIZE A
- 11 LICENSE OR REGISTRATION issued under this act shall be officially
- 12 recognized by any municipality. FOR PURPOSES OF ITS ORDINANCE.
- Sec. 7. (1) Except as otherwise provided in this act or in
- 14 subsection (3), a person , firm, or corporation shall not engage in
- 15 the business of electrical contracting unless the person , firm, or
- 16 corporation has received from the board or from the appropriate
- 17 municipality an electrical contractor's license.
- 18 (2) Except as otherwise provided in this act or in subsection
- 19 (3), a person, AN INDIVIDUAL, other than a person AN INDIVIDUAL WHO
- 20 IS licensed under this act and employed by and working under the
- 21 direction of a holder of an electrical contractor's license, shall
- 22 not in any manner undertake to execute any electrical wiring.
- 23 (3) A license under this act is not required in the execution
- 24 of the following classes of work:
- 25 (a) Minor repair work. 7 as defined in section 1.
- 26 (b) The installation, alteration, repairing, rebuilding, or
- 27 remodeling of elevators, dumbwaiters, escalators, or man lifts

- 1 performed under a permit issued by an elevator inspection agency of
- 2 the THIS state of Michigan or political subdivision of the THIS
- 3 state. of Michigan.
- 4 (c) The installation, alteration, or repair of electrical
- 5 equipment and its associated wiring installed on the premises of
- 6 consumers or subscribers by or for AN electrical energy supply or
- 7 communication agencies AGENCY for use by such agencies THAT AGENCY
- 8 in the generation, transmission, distribution, or metering of
- 9 electrical energy or for the operation of signals or transmission
- 10 of intelligence.
- 11 (d) The installation, alteration, or repair of electric wiring
- 12 for the generation and primary distribution of electric current, or
- 13 the secondary distribution system up to and including the meters,
- 14 where such THAT work is an integral part of the system owned and
- 15 operated by an electric light and power utility in rendering its
- 16 duly authorized service.
- 17 (e) Any work involved in the manufacture of electric
- 18 equipment, including the testing and repairing of such THAT
- 19 manufactured equipment.
- 20 (f) The installation, alteration, or repair of equipment and
- 21 its associated wiring for the generation or distribution of
- 22 electric energy for the operation of signals or transmission of
- 23 intelligence where such work is IF THAT WORK IS PERFORMED in
- 24 connection with a communication system owned or operated by a
- 25 telephone or telegraph company in rendering its authorized service
- 26 as a telephone or telegraph company.
- 27 (g) Any installation, alteration, or repair of electrical

- 1 equipment by a homeowner in a single family home and accompanying
- 2 outbuildings owned and occupied or to be occupied by the person
- 3 INDIVIDUAL WHO IS performing the installation, alteration, or
- 4 repair of electrical equipment.
- 5 (h) Any work involved in the use, maintenance, operation,
- 6 dismantling, or reassembling of motion picture and theatrical
- 7 equipment used in any building with approved facilities for
- 8 entertainment or educational use and which THAT has the necessary
- 9 permanent wiring and floor and wall receptacle outlets designed for
- 10 the proper and safe use of such_THAT theatrical equipment, but not
- 11 including any permanent wiring.
- 12 (i) Work performed by A mechanical contractors CONTRACTOR
- 13 licensed in classifications—A CLASSIFICATION listed in section
- 14 6(3)(a), (b), (d), (e), and (f) of the Forbes mechanical
- 15 contractors act, 1984 PA 192, MCL 338.976, A plumbing contractors
- 16 CONTRACTOR licensed under 1929 PA 266, MCL 338.901 to 338.917, THE
- 17 STATE PLUMBING ACT, 2002 PA 733, MCL 338.3511 TO 338.3569, and
- 18 employees of persons licensed under those acts, while performing
- 19 maintenance, service, repair, replacement, alteration,
- 20 modification, reconstruction, or upgrading of control wiring
- 21 circuits and electrical component parts within existing mechanical
- 22 systems defined in the mechanical and plumbing codes provided for
- 23 in the Stille-DeRossett-Hale single state construction code act,
- 24 1972 PA 230, MCL 125.1501 to 125.1531, including, but not limited
- 25 to, energy management systems, relays and controls on boilers,
- 26 water heaters, furnaces, air conditioning compressors and
- 27 condensers, fan controls, thermostats and sensors, and all

- 1 interconnecting wiring associated with the mechanical systems in
- 2 buildings which are on the load side of the unit disconnect, which
- 3 is located on or immediately adjacent to the equipment, except for
- 4 life safety systems wiring.
- 5 (j) Electrical wiring associated with the installation,
- 6 removal, alteration, or repair of a water well pump on a single
- 7 family dwelling to the first point of attachment in the house from
- 8 the well, by a registered pump installer REGISTERED under part 127
- 9 of the public health code, 1978 PA 368, MCL 333.12701 to 333.12771.
- 10 (k) The installation, maintenance, or servicing of burglar
- 11 alarm systems within a building or structure. WORK PERFORMED BY A
- 12 SYSTEM PROVIDER THAT IS REGISTERED UNDER THE SECURITY ALARM SYSTEMS
- 13 ACT, 2012 PA 580, MCL 338.2181 TO 338.2187, OR BY A SECURITY ALARM
- 14 SYSTEM CONTRACTOR LICENSED UNDER THE PRIVATE SECURITY BUSINESS AND
- 15 SECURITY ALARM ACT, 1968 PA 330, MCL 338.1051 TO 338.1092, IN
- 16 CONNECTION WITH THE INSTALLATION, MAINTENANCE, REPLACEMENT, OR
- 17 SERVICING OF A SECURITY ALARM SYSTEM OR A HOME MONITORING SYSTEM,
- 18 AND THE INSTALLATION, MAINTENANCE, REPLACEMENT, OR SERVICING OF ANY
- 19 ELECTRICAL WIRING, EQUIPMENT, OR DEVICES ASSOCIATED WITH THAT
- 20 SYSTEM. AS USED IN THIS SUBDIVISION, "HOME MONITORING SYSTEM" MEANS
- 21 A DEVICE OR AN ASSEMBLY OF EQUIPMENT AND DEVICES THAT ALLOWS
- 22 INDIVIDUALS TO REMOTELY MONITOR THEIR HOME THROUGH AUDIO, VIDEO, OR
- 23 SENSOR DETECTION SYSTEMS AND THAT MAY ALLOW THEM TO REMOTELY
- 24 CONTROL THE HOME'S ENVIRONMENT, INCLUDING, BUT NOT LIMITED TO,
- 25 CONTROLLING TEMPERATURE, HUMIDITY, LIGHTING, DOORS, OR LOCKS.
- 26 (1) The installation, maintenance, or servicing of listed
- 27 residential and commercial lawn irrigation equipment, except any

- 1 permanent wired connections exceeding 30 volts.
- 2 (m) The installation, maintenance, or servicing of listed
- 3 landscape lighting systems and equipment, except any permanent
- 4 wired connections exceeding 30 volts.
- 5 (n) The installation, alteration, maintenance, or repair of
- 6 electric signs and related wiring by an unlicensed individual under
- 7 the direct supervision of a licensed sign specialist except that
- 8 the ratio of unlicensed individuals engaged in this activity shall
- 9 not exceed 2 unlicensed individuals to 1 licensed sign specialist.
- 10 An enforcing agency shall enforce this ratio on a jobsite basis.
- 11 (o) The construction, installation, maintenance, repair, and
- 12 renovation of telecommunications equipment and related systems by a
- 13 person , firm, or corporation THAT IS primarily engaged in the
- 14 telecommunications and related information systems industry. This
- 15 exemption does not include the construction, installation,
- 16 maintenance, repair, and OR renovation of a fire alarm system.
