April 24, 2013, Introduced by Reps. Irwin, Tlaib, Zemke, Rutledge, Dillon, Singh, Schor and Ananich and referred to the Committee on Government Operations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

(MCL 388.1601 to 388.1896) by adding section 265b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 265B. (1) IT IS THE INTENT OF THE LEGISLATURE THAT A
- 2 NONCITIZEN STUDENT WHO MEETS ALL OF THE FOLLOWING REQUIREMENTS IS
- 3 ELIGIBLE TO PAY RESIDENT TUITION AT ANY PUBLIC UNIVERSITY THAT
  - RECEIVES AN APPROPRIATION UNDER SECTION 236:
    - (A) THE STUDENT MEETS 1 OF THE FOLLOWING:
- (i) is a noncitizen but is not an alien described in any of the
  - CLASSES OF INDIVIDUALS INCLUDED IN SUBPARAGRAPHS (A) TO (S) OF 8
- 8 USC 1101(A)(15).
  - (ii) HAS DEFERRED STATUS.

- 1 (B) THE STUDENT ATTENDED A PUBLIC OR PRIVATE HIGH SCHOOL IN
- 2 THIS STATE FOR 3 OR MORE YEARS.
- 3 (C) THE STUDENT GRADUATED FROM A PUBLIC OR PRIVATE HIGH SCHOOL
- 4 IN THIS STATE OR RECEIVED THE EQUIVALENT OF A HIGH SCHOOL DIPLOMA.
- 5 (D) IF THE STUDENT IS A NONCITIZEN WITHOUT A LAWFUL
- 6 IMMIGRATION STATUS, HE OR SHE HAS FILED AN AFFIDAVIT WITH THE
- 7 PUBLIC UNIVERSITY THAT STATES THAT THE STUDENT HAS FILED AN
- 8 APPLICATION FOR LAWFUL PERMANENT RESIDENCE WITH UNITED STATES
- 9 CITIZENSHIP AND IMMIGRATION SERVICES, OR WILL FILE AN APPLICATION
- 10 FOR LAWFUL PERMANENT RESIDENCE AS SOON AS HE OR SHE IS ELIGIBLE TO
- 11 DO SO.
- 12 (2) A PUBLIC UNIVERSITY SHALL KEEP ANY INFORMATION IT OBTAINS
- 13 ABOUT A STUDENT DESCRIBED IN THIS SECTION CONFIDENTIAL.
- 14 (3) AS USED IN THIS SECTION:
- 15 (A) "DEFERRED STATUS" MEANS THAT THE STUDENT HAS BEEN GRANTED
- 16 A DEFERRAL FROM PROSECUTION FOR UNLAWFUL STATUS IN THE UNITED
- 17 STATES BY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY THROUGH
- 18 THE FEDERAL EXECUTIVE BRANCH PROGRAM KNOWN AS DEFERRED ACTION FOR
- 19 CHILDHOOD ARRIVALS (DACA).
- 20 (B) "NONCITIZEN" MEANS AN INDIVIDUAL WHO IS NOT A CITIZEN OR
- 21 NATIONAL OF THE UNITED STATES.
