HOUSE BILL No. 4701

May 7, 2013, Introduced by Reps. Kowall, Cavanagh and Tlaib and referred to the Committee on Regulatory Reform.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure,"

by amending section 12 of chapter II and section 4a of chapter XI (MCL 762.12 and 771.4a), section 12 of chapter II as amended and section 4a of chapter XI as added by 1994 PA 286.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER II

Sec. 12. The court of record having jurisdiction over the criminal offense referred to in section 11 of this chapter may, at any time, terminate its consideration of the individual as a youthful trainee or, once having assigned the individual to the status of a youthful trainee, may at its discretion revoke that status any time before the individual's final release. If an individual who is required to be registered pursuant to UNDER the
