- 1 SEC. 90. (1) THE SCHOOL MASCOT REIMBURSEMENT FUND IS CREATED
 2 WITHIN THE STATE TREASURY.
- 3 (2) THE MONEY IN THE RESTRICTED ACCOUNT UNDER SECTION 478 OF 4 THE EXECUTIVE ORGANIZATION ACT OF 1965, 1965 PA 380, MCL 16.578, IS

APPROPRIATED FOR 2012-2013 TO THE SCHOOL MASCOT REIMBURSEMENT FUND.

- 6 THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM ANY
- 7 OTHER SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL
- 8 DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT
- TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
