May 28, 2013, Introduced by Reps. Franz, MacMaster, Kelly, Somerville, Genetski and Bumstead and referred to the Committee on Energy and Technology.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 32503 and 32512 (MCL 324.32503 and 324.32512), as amended by 2012 PA 247.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 32503. (1) Except as otherwise provided in this section, 2 the department, after finding that the public trust in the waters 3 will not be impaired or substantially affected, may enter into agreements pertaining to waters over and the filling in of 5 submerged patented lands, or to lease or deed unpatented lands, after approval of the state administrative board. Quitclaim-THE 6 7 DEPARTMENT MAY ISSUE OR ENTER INTO WITH ANY PERSON QUITCLAIM deeds, 8 leases, or agreements covering unpatented lands may be issued or entered into by the department with any person, and shall contain

- 25 recreational boat use, not exceeding 50 feet in length where the
- 26 spoil is not disposed of below the ordinary high-water mark of the
