A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811x.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811X. (1) NO LATER THAN JUNE 1, 2014, THE SECRETARY OF
- 2 STATE SHALL DEVELOP AND MAY ISSUE A FUND-RAISING PLATE OR COLLECTOR
- 3 PLATE RECOGNIZING MICHIGAN VETERANS. A FUND-RAISING PLATE OR
- 4 COLLECTOR PLATE DEVELOPED UNDER THIS SECTION SHALL BE OF A DESIGN
- 5 AS DETERMINED BY THE SECRETARY OF STATE. THE SECRETARY OF STATE
- 6 SHALL TRANSFER FUND-RAISING DONATIONS FOR PLATES RECOGNIZING
- 7 MICHIGAN VETERANS COLLECTED UNDER SECTIONS 811F AND 811G TO THE
- STATE TREASURER, WHO SHALL DISBURSE THE DONATION MONEY TO THE
- MICHIGAN VETERANS ENGAGEMENT FUND ESTABLISHED UNDER THIS SECTION.

- 1 THE STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
- 2 ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE
