A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 601e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 601E. (1) A PERSON WHO COMMITS A MOVING VIOLATION AND AS
- 2 A RESULT CAUSES THE SERIOUS IMPAIRMENT OF A BODY FUNCTION OF A
- 3 VULNERABLE ROADWAY USER ON A HIGHWAY WHO IS IN COMPLIANCE WITH THIS
- 4 ACT IS GUILTY OF A MISDEMEANOR PUNISHABLE BY ANY OF THE FOLLOWING:
- 5 (A) IMPRISONMENT FOR NOT MORE THAN 93 DAYS.
 - (B) A FINE OF NOT MORE THAN \$1,000.00.
 - (C) COMMUNITY SERVICE FOR NOT MORE THAN 180 HOURS.
- 8 (2) A PERSON WHO COMMITS A MOVING VIOLATION AND AS A RESULT
- 9 CAUSES DEATH TO A VULNERABLE ROADWAY USER ON A HIGHWAY WHO IS IN
- 10 COMPLIANCE WITH THIS ACT IS GUILTY OF A MISDEMEANOR PUNISHABLE BY

11 ANY OF THE FOLLOWING:

- 1 (A) IMPRISONMENT FOR NOT MORE THAN 1 YEAR.

- 23 (A) "MOVING VIOLATION" MEANS AN ACT OR OMISSION PROHIBITED
- 24 UNDER THIS ACT OR A LOCAL ORDINANCE SUBSTANTIALLY CORRESPONDING TO
- 25 THIS ACT THAT OCCURS WHILE A PERSON IS OPERATING A MOTOR VEHICLE
- 26 AND FOR WHICH THE PERSON IS SUBJECT TO A FINE.
- 27 (B) "NONMOTORIZED TRANSPORTATION DEVICE" MEANS A DEVICE IN,

- 1 UPON, OR BY WHICH ANY PERSON OR PROPERTY, OR BOTH, IS OR MAY BE
- 2 TRANSPORTED OR DRAWN UPON A HIGHWAY BY HUMAN POWER, THAT IS NOT

- 10 OPERATING A NONMOTORIZED TRANSPORTATION DEVICE.
