## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1279H. (1) THE DEPARTMENT SHALL DO ALL OF THE FOLLOWING
- 2 WITH RESPECT TO EACH TEST OR ASSESSMENT THAT PUBLIC SCHOOL PUPILS
- 3 ARE REQUIRED TO TAKE UNDER STATE LAW:
- 4 (A) MAKE AVAILABLE FOR PUBLIC INSPECTION AT THE DEPARTMENT ALL
  - TEST QUESTIONS OR ASSESSMENT ASSIGNMENTS THAT ARE USED AS PART OF
  - THE TEST OR ASSESSMENT FOR THE CURRENT SCHOOL YEAR, THAT WERE USED
  - AS PART OF THE TEST OR ASSESSMENT FOR THE IMMEDIATELY PRECEDING
  - SCHOOL YEAR, AND, IF AVAILABLE, ARE EXPECTED TO BE USED AS PART OF
  - THE TEST OR ASSESSMENT THE NEXT TIME IT IS ADMINISTERED.
    - (B) WORK WITH SCHOOL DISTRICTS, PUBLIC SCHOOL ACADEMIES, AND

- 1 INTERMEDIATE SCHOOL DISTRICTS TO ENSURE THAT ALL TEST QUESTIONS OR
- 2 ASSESSMENT ASSIGNMENTS DESCRIBED IN SUBDIVISION (A) ARE MADE
- 3 AVAILABLE FOR INSPECTION BY PARENTS AND LEGAL GUARDIANS AT EACH
- 4 PUBLIC SCHOOL AT WHICH THE SPECIFIC TEST OR ASSESSMENT IS
- 5 ADMINISTERED.
- 6 (2) THE OPPORTUNITY FOR INSPECTION OF TEST QUESTIONS OR
- 7 ASSESSMENT ASSIGNMENTS REQUIRED UNDER SUBSECTION (1) SHALL BE AN
- 8 OPPORTUNITY TO INSPECT THE TEST QUESTIONS OR ASSESSMENT ASSIGNMENTS
