A bill to amend 1996 PA 354, entitled

"Savings bank act,"

(MCL 487.3101 to 487.3804) by adding section 436.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 436. (1) A SAVINGS BANK THAT OWNS, OPERATES, OR MANAGES
- 2 AN AUTOMATED TELLER MACHINE LOCATED ON THE PREMISES OF A CASINO,
- 3 CASINO ENTERPRISE, LIQUOR STORE, OR ADULT ENTERTAINMENT
- 4 ESTABLISHMENT SHALL ENSURE THAT THE AUTOMATED TELLER MACHINE DOES
- 5 NOT ALLOW AN INDIVIDUAL ACCESS TO CASH BENEFITS FROM A MICHIGAN
- 6 BRIDGE CARD.

- 8 (A) "ADULT ENTERTAINMENT ESTABLISHMENT" MEANS ANY OF THE
