HOUSE BILL No. 4890

June 20, 2013, Introduced by Reps. McBroom and Nathan and referred to the Committee on Regulatory Reform.

A bill to amend 1968 PA 251, entitled "Cemetery regulation act,"

(MCL 456.521 to 456.543) by adding section 17.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17. (1) A PERSON POSSESSING THE RIGHT TO A SPACE WITHIN A
- 2 CEMETERY IS PRESUMED TO HAVE ABANDONED THE RIGHT TO A SPACE IF ALL
- 3 OF THE FOLLOWING APPLY:
- 4 (A) DURING THE PAST 50 YEARS, THE PERSON POSSESSING THE RIGHT
- 5 TO A SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT
- 6 PROVIDED THE CEMETERY OWNER OR OPERATOR WITH AN UPDATED ADDRESS FOR
- 7 PURPOSES OF CONTACTING THE PERSON.
- 8 (B) DURING THE PAST 50 YEARS, THE PERSON POSSESSING THE RIGHT
- TO A SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE HAS NOT
- 10 CONTACTED THE CEMETERY OWNER OR OPERATOR AND AFFIRMED POSSESSION OF
- 11 THE RIGHT TO A SPACE IN ANY OF THE FOLLOWING WAYS:

- 1 (i) REQUESTING A BURIAL OR NOTIFYING THE CEMETERY OWNER OR
- 2 OPERATOR OF A BURIAL UNDER THE RIGHT TO A SPACE.
- 3 (ii) REQUESTING AN INSTALLATION OF A MEMORIAL OR NOTIFYING THE
- 4 CEMETERY OWNER OR OPERATOR OF AN INSTALLATION OF A MEMORIAL UNDER
- 5 THE RIGHT TO A SPACE.
- 6 (iii) INDICATING OR REQUESTING A TRANSFER OF THE RIGHT TO A
- 7 SPACE TO ANOTHER PERSON.
- 8 (iv) MAKING A PAYMENT TO THE CEMETERY OWNER OR OPERATOR
- 9 RELATING TO THE RIGHT TO A SPACE.
- 10 (v) AFFIRMING IN WRITING THE POSSESSION OF THE RIGHT TO A
- 11 SPACE.
- 12 (C) A MEMORIAL HAS NOT BEEN INSTALLED AT THE CEMETERY UNDER
- 13 THE RIGHT TO A SPACE.
- 14 (D) REMAINS HAVE NOT BEEN INTERRED AT THE CEMETERY UNDER THE
- 15 RIGHT TO A SPACE.
- 16 (2) IF THE RIGHT TO A SPACE WITHIN A CEMETERY IS PRESUMED TO
- 17 BE ABANDONED UNDER SUBSECTION (1) AND THE CEMETERY OWNER OR
- 18 OPERATOR SATISFIES THE REQUIREMENTS UNDER SUBSECTIONS (3) AND (4)
- 19 FOR NOTICE TO THE PERSON POSSESSING THE RIGHT TO A SPACE, THE
- 20 CEMETERY OWNER OR OPERATOR MAY UNDER SUBSECTION (5) CERTIFY THE
- 21 RIGHT TO A SPACE AS ABANDONED.
- 22 (3) BEFORE CERTIFYING A RIGHT TO A SPACE WITHIN A CEMETERY AS
- 23 ABANDONED, A CEMETERY OWNER OR OPERATOR SHALL POST ON THE SPACE
- 24 WITHIN THE CEMETERY FOR 60 CONSECUTIVE DAYS A WRITTEN NOTICE OF
- 25 INTENT TO CERTIFY THE RIGHT TO A SPACE AS ABANDONED. IF THE
- 26 CEMETERY OWNER OR OPERATOR HAS AN ADDRESS FOR THE PERSON POSSESSING
- 27 THE RIGHT TO A SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE, THE

- 1 CEMETERY OWNER OR OPERATOR SHALL ALSO SEND TO THAT ADDRESS A
- 2 WRITTEN NOTICE OF INTENT TO CERTIFY THE RIGHT TO A SPACE AS
- 3 ABANDONED. THE NOTICE SHALL BE SENT BY CERTIFIED MAIL WITH A RETURN
- 4 RECEIPT REQUESTED. A NOTICE UNDER THIS SUBSECTION OR SUBSECTION (4)
- 5 SHALL BE IN A FORM PRESCRIBED BY THE CEMETERY COMMISSIONER.
- 6 (4) THE CEMETERY OWNER OR OPERATOR SHALL ALSO PUBLISH A NOTICE
- 7 OF INTENT TO CERTIFY THE RIGHT TO A SPACE AS ABANDONED IN A
- 8 NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY IN WHICH THE
- 9 CEMETERY IS LOCATED IF ANY OF THE FOLLOWING APPLY:
- 10 (A) THE CEMETERY OWNER OR OPERATOR DOES NOT HAVE AN ADDRESS
- 11 FOR THE PERSON POSSESSING THE RIGHT TO A SPACE OR THE PERSON'S
- 12 AUTHORIZED REPRESENTATIVE.
- 13 (B) WHETHER OR NOT A WRITTEN NOTICE MAILED UNDER SUBSECTION
- 14 (3) IS RETURNED AS UNDELIVERABLE, THE PERSON POSSESSING THE RIGHT
- 15 TO A SPACE OR THE PERSON'S AUTHORIZED REPRESENTATIVE DOES NOT
- 16 CONTACT THE CEMETERY OWNER OR OPERATOR AND AFFIRM THE PERSON'S
- 17 POSSESSION RIGHTS WITHIN 60 DAYS AFTER THE NOTICE IS MAILED.
- 18 (5) IF MORE THAN 60 DAYS HAVE ELAPSED SINCE THE CEMETERY OWNER
- 19 OR OPERATOR PUBLISHED A NOTICE IN A NEWSPAPER UNDER SUBSECTION (4)
- 20 AND THE PERSON POSSESSING THE RIGHT TO A SPACE OR THE PERSON'S
- 21 AUTHORIZED REPRESENTATIVE HAS NOT CONTACTED THE CEMETERY OWNER OR
- 22 OPERATOR AND AFFIRMED THE PERSON'S POSSESSION RIGHTS, THE CEMETERY
- 23 OWNER OR OPERATOR MAY FILE A CERTIFIED NOTICE OF ABANDONMENT OF A
- 24 RIGHT TO A SPACE WITH THE CEMETERY COMMISSIONER ON A FORM
- 25 PRESCRIBED BY THE CEMETERY COMMISSIONER. THE NOTICE SHALL INCLUDE A
- 26 DESCRIPTION OF THE RIGHT TO A SPACE AFFECTED AND THE NAMES OF ANY
- 27 PERSONS POSSESSING THE RIGHT TO THE SPACE KNOWN TO THE CEMETERY

- 1 OWNER OR OPERATOR. THE FORM SHALL REQUIRE THAT THE CEMETERY OWNER
- 2 OR OPERATOR CERTIFY ALL OF THE FOLLOWING WITH RESPECT TO THE RIGHT
- 3 TO A SPACE:
- 4 (A) THAT THE RIGHT TO A SPACE IS PRESUMED TO BE ABANDONED
- 5 UNDER THE CRITERIA SET FORTH IN SUBSECTION (1).
- 6 (B) THAT THE CEMETERY OWNER OR OPERATOR PROVIDED NOTICE IN
- 7 COMPLIANCE WITH SUBSECTIONS (3) AND (4).
- 8 (C) THAT THE CEMETERY OWNER OR OPERATOR HAS NOT RECEIVED A
- 9 RESPONSE TO A NOTICE UNDER SUBSECTION (3) OR (4) FROM A PERSON
- 10 POSSESSING A RIGHT TO A SPACE OR THE PERSON'S AUTHORIZED
- 11 REPRESENTATIVE AFFIRMING THE PERSON'S POSSESSION RIGHTS.
- 12 (6) ALL OF THE FOLLOWING APPLY UPON FILING OF A CERTIFIED
- 13 NOTICE UNDER SUBSECTION (5):
- 14 (A) THE RIGHT TO A SPACE IS CERTIFIED AS ABANDONED BY PERSONS
- 15 PREVIOUSLY POSSESSING THE RIGHT.
- 16 (B) A PERSON LATER ASSERTING ANY CONTRACTUAL RIGHTS TO THE
- 17 RIGHT TO A SPACE MAY ONLY SEEK A REMEDY UNDER SUBSECTION (8).
- 18 (7) IF A PERSON POSSESSING A RIGHT TO A SPACE WITHIN A
- 19 CEMETERY OR THE PERSON'S AUTHORIZED REPRESENTATIVE IS NOTIFIED BY
- 20 THE CEMETERY OWNER OR OPERATOR UNDER SUBSECTION (3) OR (4) AND THE
- 21 PERSON OR THE PERSON'S AUTHORIZED REPRESENTATIVE DOES NOT SEEK TO
- 22 RETAIN POSSESSION OF THE RIGHT TO A SPACE, THE PERSON OR THE
- 23 PERSON'S AUTHORIZED REPRESENTATIVE MAY TRANSFER THE RIGHT TO A
- 24 SPACE BACK TO THE CEMETERY OWNER OR OPERATOR FOR AN AMOUNT AS
- 25 AGREED BY THE PARTIES.
- 26 (8) AFTER A CERTIFIED NOTICE IS FILED UNDER SUBSECTION (5), A
- 27 PERSON WITH A CONTRACTUAL RIGHT TO A SPACE IS ENTITLED ONLY TO THE

- 1 FOLLOWING REMEDIES FOR ANY BREACH OF THE CONTRACTUAL RIGHT:
- 2 (A) THE CEMETERY OWNER OR OPERATOR SHALL REINSTATE THE RIGHT
- 3 TO A SPACE IF THE ORIGINAL CONTRACTUAL RIGHT TO A SPACE HAS NOT
- 4 BEEN RESOLD OR OTHERWISE TRANSFERRED TO ANOTHER PERSON.
- 5 (B) IF THE ORIGINAL CONTRACTUAL RIGHT TO A SPACE HAS BEEN
- 6 RESOLD, THE CEMETERY OWNER OR OPERATOR, AT THE OPTION OF THE PERSON
- 7 WITH THE ORIGINAL CONTRACTUAL RIGHT TO A SPACE, SHALL DO EITHER OF
- 8 THE FOLLOWING:
- 9 (i) PROVIDE AT NO COST A DIFFERENT RIGHT TO A SPACE OF A
- 10 COMPARABLE VALUE WITHIN THE CEMETERY.
- 11 (ii) PAY THE PERSON WITH THE ORIGINAL CONTRACTUAL RIGHT TO A
- 12 SPACE AN AMOUNT NOT EXCEEDING 65% OF THE PRICE FOR WHICH THE
- 13 ORIGINAL CONTRACTUAL RIGHT TO A SPACE WAS RESOLD OR OTHERWISE
- 14 TRANSFERRED.
- 15 (9) A CONTRACT FOR THE SALE OF A RIGHT TO A SPACE ENTERED INTO
- 16 BY A CEMETERY OWNER OR OPERATOR AFTER THE EFFECTIVE DATE OF THIS
- 17 SECTION SHALL CONTAIN A WRITTEN NOTICE OF THE PRESUMPTION OF
- 18 ABANDONMENT OF A RIGHT TO A SPACE UNDER SUBSECTION (1) AND MAY
- 19 IMPOSE A LEGAL DUTY TO KEEP THE CEMETERY OWNER OR OPERATOR INFORMED
- 20 IN WRITING OF A CURRENT RESIDENCE ADDRESS OF THE PERSON POSSESSING
- 21 THE RIGHT TO A SPACE UNDER THE CONTRACT OR OF THE PERSON'S
- 22 AUTHORIZED REPRESENTATIVE.
- 23 (10) IF THE CEMETERY COMMISSIONER DETERMINES THAT A PROCESS
- 24 FOR SATISFYING LEGAL REQUIREMENTS FOR THE PROVISION OF NOTICE USING
- 25 AN INTERNET SEARCH HAS BEEN RECOGNIZED BY THE COURTS OF THIS STATE
- 26 AND IS PRACTICABLE, THE CEMETERY COMMISSIONER SHALL PROMULGATE
- 27 RULES UNDER THE ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306,

- 1 MCL 24.201 TO 24.328, FOR THE PROVISION OF NOTICE UNDER THIS
- 2 SECTION USING AN INTERNET SEARCH AND, IN ADDITION TO THE PROVISION
- 3 OF NOTICE BY MAIL UNDER SUBSECTION (3), A CEMETERY OWNER OR
- 4 OPERATOR SEEKING TO CERTIFY A RIGHT TO A SPACE WITHIN THE CEMETERY
- 5 AS ABANDONED ALSO SHALL PROVIDE NOTICE AS PROVIDED UNDER THE
- 6 ADMINISTRATIVE RULES.
- 7 (11) THE PURPOSE OF THIS SECTION IS INTENDED TO ADVANCE THE
- 8 SIGNIFICANT AND LEGITIMATE PUBLIC PURPOSE OF ASSURING THE
- 9 AVAILABILITY AND PRODUCTIVE USE OF SPACE WITHIN CEMETERIES AND
- 10 PROVIDING SECURITY IN CONTRACTUAL RIGHTS CONSISTENT WITH THE
- 11 HEALTH, SAFETY, AND WELFARE OF THE PEOPLE OF THIS STATE.
- 12 (12) AS USED IN THIS SECTION, "RIGHT TO A SPACE" MEANS A
- 13 BURIAL RIGHT, COLUMBARIUM RIGHT, OR ENTOMBMENT RIGHT WITHIN A
- 14 CEMETERY.
- 15 Enacting section 1. This amendatory act takes effect January
