## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 682D. (1) A LOCAL UNIT OF GOVERNMENT MAY, BY RESOLUTION,
- 2 AUTHORIZE EMPLOYEES AND VOLUNTEERS OF A CHARITABLE ORGANIZATION TO
- 3 CONDUCT FUND-RAISING ACTIVITIES WITHIN THE IMPROVED PORTION OF A
- 4 STREET OR HIGHWAY THAT IS WITHIN THE JURISDICTION OF THAT LOCAL
