A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 657a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 657A. (1) A VILLAGE, CITY, OR TOWNSHIP MAY BY RESOLUTION
- 2 ALLOW THE OPERATION OF GOLF CARTS ON THE STREETS OF THAT VILLAGE,
- 3 CITY, OR TOWNSHIP, SUBJECT TO THE REQUIREMENTS OF THIS SECTION.
- 4 (2) IF A VILLAGE, CITY, OR TOWNSHIP ALLOWS THE OPERATION OF
- 5 GOLF CARTS ON THE STREETS OF THAT VILLAGE, CITY, OR TOWNSHIP, THAT
- 6 VILLAGE, CITY, OR TOWNSHIP MAY REQUIRE THOSE GOLF CARTS AND THE
- 7 OPERATORS OF THOSE GOLF CARTS TO BE REGISTERED WITHIN THAT VILLAGE,
- 8 CITY, OR TOWNSHIP. A VILLAGE, CITY, OR TOWNSHIP SHALL NOT CHARGE A
