HOUSE BILL No. 5099

October 23, 2013, Introduced by Reps. Victory, Jacobsen and MacGregor and referred to the Committee on Financial Liability Reform.

A bill to amend 2005 PA 92, entitled "School bond qualification, approval, and loan act," by amending section 7 (MCL 388.1927), as amended by 2012 PA 437.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 7. (1) The state treasurer shall qualify bonds of a school district if the state treasurer determines all of the following:
 - (a) A majority of the school district electors have approved the bonds.
 - (b) The terms of the bond issue comply with applicable provisions of the revised school code, 1976 PA 451, MCL 380.1 to 380.1852.

- 1 (c) The school district is in compliance with the revised
- 2 municipal finance act, 2001 PA 34, MCL 141.2101 to 141.2821.
- 3 (d) The weighted average maturity of the qualified bond issue
- 4 does not exceed 120% of the average reasonably expected useful life
- 5 of the facilities, excluding land and site improvements, being
- 6 financed or refinanced with the proceeds of the bonds, determined
- 7 as of the later of the date on which the qualified bonds will be
- 8 issued or the date on which each facility is expected to be placed
- 9 in service.
- 10 (e) The school district has filed any information necessary to
- 11 update the contents of the original application to reflect changes
- 12 in any of the information approved in the preliminary qualification
- 13 process.
- 14 (f) The school district has agreed that the school district

- 17 request of the state treasurer, the school district will promptly,

- 22 district as to the investment and expenditure of the proceeds of
