## **HOUSE BILL No. 5130**

November 5, 2013, Introduced by Rep. Townsend and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled

"The revised school code,"

by amending section 1201 (MCL 380.1201), as amended by 2001 PA 27.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1201. (1) The business that the board of a school
- 2 district OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY is
- 3 authorized to perform shall be conducted at a public meeting of the
- 4 board held in compliance with the open meetings act, 1976 PA 267,
- 5 MCL 15.261 to 15.275. An act of the board OR BOARD OF DIRECTORS is
- 6 not valid unless the act is authorized at a meeting by a majority
- 7 vote of the members elected or appointed to and serving on the
- 8 board OR BOARD OF DIRECTORS and a proper record is made of the
- 9 vote.
  - (2) The board OR BOARD OF DIRECTORS may hold closed sessions

- 1 only as authorized by section 8 of the open meetings act, 1976 PA
- 2 267, MCL 15.268.
- 3 (3) A meeting at which all members are present, with or
- 4 without proper notice to members of the board OR BOARD OF
- 5 DIRECTORS, and for which proper notice is given to the public
- 6 pursuant to subsection (4), is considered a legal meeting for the
- 7 transaction of business.
- 8 (4) The board OR BOARD OF DIRECTORS shall give public notice
- 9 of the time, date, and place of the meeting in the manner required
- 10 by the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.
- 11 (5) The minutes of each board OR BOARD OF DIRECTORS meeting
- 12 shall be signed by the secretary. In the absence of the secretary,
- 13 the president shall appoint a temporary secretary who shall sign
- 14 the minutes of the meeting. The vice-president shall act in the
- 15 absence of the president.
- 16 (6) IN ADDITION TO THE OTHER REQUIREMENTS OF THIS SECTION, ALL
- 17 OF THE FOLLOWING APPLY TO REGULAR MEETINGS OF A BOARD OR BOARD OF
- 18 DIRECTORS:
- 19 (A) THE MEETING SHALL BE HELD AT THE BOARD OR BOARD OF
- 20 DIRECTORS OFFICE, AT A SCHOOL OPERATED BY THE BOARD OR BOARD OF
- 21 DIRECTORS, OR AT ANOTHER READILY ACCESSIBLE LOCATION THAT HAS
- 22 SUFFICIENT CAPACITY AND IS LOCATED WITHIN 2 MILES OF A SCHOOL
- 23 OPERATED BY THE BOARD OR BOARD OF DIRECTORS.
- 24 (B) THE BOARD OR BOARD OF DIRECTORS SHALL ENSURE THAT AN
- 25 AGENDA IS POSTED ON THE SCHOOL DISTRICT'S OR PUBLIC SCHOOL
- 26 ACADEMY'S WEBSITE AT LEAST 72 HOURS BEFORE THE MEETING TIME AND
- 27 THAT COPIES OF THE WRITTEN AGENDA ARE AVAILABLE AT THE MEETING AT

- 3 OF EACH MEETING ARE POSTED ON THE SCHOOL DISTRICT'S OR PUBLIC
- 4 SCHOOL ACADEMY'S WEBSITE, AND ARE MADE AVAILABLE AT NO CHARGE AT
- 5 THE BOARD OR BOARD OF DIRECTORS OFFICE, WITHIN 72 HOURS AFTER THE
- 6 CONCLUSION OF THE MEETING.
