## **HOUSE BILL No. 5189**

A bill to require certain customer security measures at gas stations and convenience stores; and to prescribe civil sanctions.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
  "Jessica Heeringa act".
- 3 Sec. 3. As used in this act:
  - (a) "Convenience store" means a business establishment in this state that is primarily engaged in the retail sale of convenience goods, or both convenience goods and gasoline, and has at least 1 employee on the premises during normal operating hours. The term does not include a hotel or other business engaged in providing lodging, a tavern, a restaurant, a store that sells prescription

- 1 drugs, a grocery store, a supermarket, a retail business that has
- 2 more than 10,000 square feet of retail floor space, a farmer's
- 3 market, a roadside stand, an on-site farm market, or another
- 4 business engaged in an agricultural activity or operation.
- 5 (b) "Gas station" means a business establishment in this state
- 6 that is engaged in the retail sale of gasoline to the public.
- 7 (c) "Qualified establishment" means a convenience store or gas
- 8 station that is open to the general public for the sale of gasoline
- 9 or other goods at any time after 11 p.m. and before 5 a.m.
- 10 (d) "Security camera system" means a digital security camera
- 11 that is capable of producing a retrievable image on film or tape
- 12 that can be enlarged through projection or other means.
- Sec. 5. (1) The owner or operator of a qualified establishment
- 14 shall ensure that 1 of the following is met at any time after 11
- 15 p.m. and before 5 a.m. that the establishment is open for business:
- 16 (a) At least 1 employee is on duty at the establishment; the
- 17 establishment has installed a security camera system at the
- 18 establishment; and that security camera system is in good working
- 19 order and operates continuously at all times.
- 20 (b) At least 2 employees are on duty at the establishment at
- 21 all times.
- 22 (2) The owner or operator of a qualified establishment that
- 23 installs a security camera system shall ensure that the security
- 24 camera system is maintained in good working order at all times.
- 25 Sec. 7. A person that violates this act is responsible for a
- 26 state civil infraction and may be ordered to pay a civil fine of
- 27 not more than \$200.00 for each violation.
