A bill to amend 1961 PA 236, entitled
"Revised judicature act of 1961,"
by amending section 4701 (MCL 600.4701), as amended by 2010 PA 363.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4701. As used in this chapter:

2 (a) "Crime" means committing, attempting to commit, conspiring
3 to commit, or soliciting another person to commit any of the
4 following offenses in connection with which the forfeiture of
5 property is sought:

6 (i) A violation of part 111 of the natural resources and
7 environmental protection act, 1994 PA 451, MCL 324.11101 to
8 324.11153.

9 (ii) A violation of part 121 of the natural resources and

1 environmental protection act, 1994 PA 451, MCL 324.12101 to
2 324.12117.

3 (iii) A violation of section 4, 5, or 7 of the medicaid false
4 claim act, 1977 PA 72, MCL 400.604, 400.605, and 400.607.

5 (iv) A violation of section 2 or 3 of the Michigan antitrust
6 reform act, 1984 PA 274, MCL 445.772 and 445.773.

7 (v) A violation described in ~~section 409 of the uniform~~
8 ~~securities act, 1964 PA 265, MCL 451.809, or~~ section 508 of the
9 uniform securities act (2002), 2008 PA 551, MCL 451.2508.

10 (vi) A violation of section 5 or 7 of 1978 PA 33, MCL 722.675
11 and 722.677.

7 (b) "Instrumentality of a crime" means any property, other
8 than real property, the use of which contributes directly and
9 materially to the commission of a crime.

10 (c) "Person" means an individual, corporation, limited
11 liability company, partnership, or other business entity, or an
12 unincorporated or voluntary association.

13 (d) "Proceeds of a crime" means any property obtained through
14 the commission of a crime, including any appreciation in the value
15 of the property.

16 (e) "Security interest" means any interest in real or personal
17 property that secures payment or performance of an obligation.

18 (f) "Substituted proceeds of a crime" means any property
19 obtained or any gain realized by the sale or exchange of proceeds
20 of a crime.

21 Enacting section 1. This amendatory act does not take effect
22 unless Senate Bill No. ____ or House Bill No. 5234 (request no.
23 03727'13) of the 97th Legislature is enacted into law.
