A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 2978.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2978. (1) AN INDIVIDUAL DESCRIBED IN SUBSECTION (2) WHO,

- 3 HER EMPLOYMENT, HAS REASONABLE CAUSE TO SUSPECT HUMAN TRAFFICKING
- 4 AND WHO IN GOOD FAITH REPORTS THE SUSPECTED HUMAN TRAFFICKING TO A
- 5 LAW ENFORCEMENT AGENCY OR COOPERATES IN AN INVESTIGATION OF THE
- SUSPECTED HUMAN TRAFFICKING IS IMMUNE FROM CIVIL LIABILITY FOR THE
 - REPORTING OR COOPERATION.

- 26 (5) AS USED IN THIS SECTION, "HUMAN TRAFFICKING" MEANS AN ACT
- 27 THAT IS A VIOLATION OF CHAPTER LXVIIA OF THE MICHIGAN PENAL CODE,
