## **HOUSE BILL No. 5402**

March 11, 2014, Introduced by Reps. Potvin, McBroom, Graves, Schmidt, Goike, LaFontaine, Clemente, Jacobsen, Bumstead, Kivela, Zorn, Rendon, Dianda, Foster, MacGregor, Glardon, Victory, Kesto, Haveman, Poleski, Forlini, Haugh, Lane, Brunner, Durhal, Santana and Crawford and referred to the Committee on Natural Resources.

A bill to amend 1955 PA 162, entitled

"An act to provide for the licensing and inspection of agricultural liming material and to regulate the sale thereof; and to prescribe penalties for the violations of the provisions of this act,"

by amending section 2 (MCL 290.532).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 2. (1) Before any liming material is sold or offered for

- sale, the manufacturer, importer or party who causes it to be sold or offered for sale within this state shall file with the director of THE DEPARTMENT OF agriculture AND RURAL DEVELOPMENT a certified copy of the analysis and certificate referred to in section 1. The certified copy of analysis shall be accompanied, when IF the director of agriculture so requests, by a sealed package containing not less than 2 pounds of such THE liming material, with an

affidavit that it is a representative sample of the liming material

- 14 AGRICULTURAL AND MANAGEMENT PRACTICES, BASED ON THE ANALYSIS UNDER
- 15 SUBDIVISION (B) (ii).
- 16 (B) A LABORATORY ANALYSIS REPORT THAT CONTAINS ALL OF THE
- 17 FOLLOWING, SUBJECT TO SUBSECTION (3):
- 18 (i) SAMPLING TEST RESULTS THAT DEMONSTRATE THAT THE LEVEL OF
- 19 METALS IN THE LIMING MATERIAL DOES NOT POSE A RISK OF HARM TO HUMAN
- 20 HEALTH OR THE ENVIRONMENT. THIS REQUIREMENT CAN BE SATISFIED BY
- 21 COMPLYING WITH THE LEVELS ESTABLISHED PURSUANT TO THE ASSOCIATION
- 22 OF AMERICAN PLANT FOOD CONTROL OFFICIALS' STATEMENT OF UNIFORM
- 23 INTERPRETATION AND POLICY NUMBER 25.
- 24 (ii) BOTH OF THE FOLLOWING:
- 25 (A) THE PERCENTAGE OF DRY SOLIDS IN THE LIMING MATERIAL.
- 26 (B) THE LEVELS OF CALCIUM, MAGNESIUM, SULFATE, CHROMIUM,
- 27 COPPER, SILVER, AND BORON IN THE LIMING MATERIAL.

- 1 (C) SUBJECT TO SUBSECTION (3), SCIENTIFICALLY ACCEPTABLE DATA
- 2 THAT GIVE REASONABLE ASSURANCE THAT THE LIMING MATERIAL WILL
- 3 CORRECT SOIL ACIDITY.
- 4 (3) THE SAME LABORATORY ANALYSIS REPORT UNDER SUBSECTION
- 5 (2)(B) AND SCIENTIFICALLY ACCEPTABLE DATA UNDER SUBSECTION (2)(C)
- 6 INCLUDED WITH AN APPLICATION FOR 1 YEAR MAY BE INCLUDED WITH AN
- 7 APPLICATION FOR A SUBSEQUENT YEAR UNLESS THE RAW MATERIALS OR
- 8 PROCESSES USED TO GENERATE THE SPECIALTY LIMING MATERIAL HAVE
- 9 CHANGED IN A WAY THAT CAN REASONABLY BE EXPECTED TO MATERIALLY
- 10 AFFECT THE LABORATORY ANALYSIS REPORT OR SCIENTIFICALLY ACCEPTABLE
- 11 DATA.
- 12 Enacting section 1. This amendatory act does not take effect
- unless Senate Bill No. \_\_\_\_ or House Bill No. 5400 (request no.
- 14 00948'13 \*\*) of the 97th Legislature is enacted into law.
