April 23, 2014, Introduced by Reps. Victory and Hooker and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1966 PA 138, entitled "The family support act,"

by amending section 4 (MCL 552.454), as amended by 1999 PA 158.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) If the county family independence agency
- 2 DEPARTMENT OF HUMAN SERVICES where the custodial parent or guardian
- 3 of the minor child or children or the child or children who have
- 4 reached 18 years of age resides determines the custodial parent,
- 5 the minor child or children, the child or children who have reached
- 6 18 years of age, or any of them to be eligible for public or
- 7 medical assistance, or if a complaint is being filed under section
- 8 1b, the prosecuting attorney shall act as the attorney for the
- 9 petitioner.

- 14 in petitioning for child support. Upon certification by the family
- 15 independence agency DEPARTMENT OF HUMAN SERVICES that the custodial
- 16 parent and minor child or children or child or children who have
- 17 reached 18 years of age are receiving public assistance, a payment
- 18 received by the friend of the court or the state disbursement unit
- 19 for the support of the custodial parent and minor child or children
- 20 or child or children who have reached 18 years of age shall be

- 23 Enacting section 1. This amendatory act takes effect 90 days
- 24 after the date it is enacted into law.
