

# HOUSE BILL No. 5720

August 13, 2014, Introduced by Rep. McCann and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
 "The code of criminal procedure,"  
 by amending section 12m (MCL 777.12m), as amended by 2005 PA 54.
