## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2 supervise the establishment and maintenance of a statewide 3 qualified voter file. The secretary of state shall establish the technology to implement the qualified voter file on or before 4 5 January 1, 1997. The qualified voter file shall be-IS the official 6 file for the conduct of all elections held in this state on or 7 after January 1, 1998. The secretary of state may direct that all or any part of the city, township, or village registration files shall be used in conjunction with the qualified voter file at the 10 first state primary and election held after the creation of the 11 qualified voter file.

- 3 in an election and whose name appears in the qualified voter file
