## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 413. (1) A DOMESTIC CREDIT UNION THAT OWNS, OPERATES, OR

- 5 NOT ALLOW AN INDIVIDUAL ACCESS TO CASH BENEFITS FROM A MICHIGAN

- 27 (A) A GROCERY STORE THAT SELLS GROCERIES, INCLUDING STAPLE

- 1 FOODS, AND IS LOCATED IN A CASINO OR A CASINO ENTERPRISE.
- 2 (B) ANY OTHER BUSINESS ESTABLISHMENT THAT OFFERS GAMING THAT
