SENATE BILL No. 520

September 19, 2013, Introduced by Senators EMMONS and COLBECK and referred to the Committee on Families, Seniors and Human Services.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 165 (MCL 750.165), as amended by 2004 PA 570.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 165. (1) If the court orders an individual to pay support for the individual's former or current spouse, or for a child of the individual, and the individual does not pay the support in the amount or at the time stated in the order, the individual is guilty of a felony punishable by imprisonment for not more than 4 years or by a fine of not more than \$2,000.00, or both.
 - (2) This section does not apply unless the individual ordered to pay support appeared in, or received notice by personal service of, the action in which the support order was issued.HAD NOTICE OF

- 22 support and parenting time enforcement act, 1982 PA 295, MCL
- 23 552.631, is outstanding for an individual when the individual is
- 24 arrested for a violation of this section, the court shall notify

- 1 (4) The court may suspend the sentence of an individual
- 2 convicted under this section if the individual files with the court
- 3 a bond in the amount and with the sureties the court requires. At a
- 4 minimum, the bond must be conditioned on the individual's
- 5 compliance with the support order. If the court suspends a sentence
- 6 under this subsection and the individual does not comply with the
- 7 support order or another condition on the bond, the court may order
- 8 the individual to appear and show cause why the court should not
- 9 impose the sentence and enforce the bond. After the hearing, the

- 17 ARREARAGE UNDER THE SUPPORT ORDER. THE RESTITUTION ORDER SHALL
- 18 REFERENCE THE SUPPORT ORDER AND DIRECT THE INDIVIDUAL TO PAY THE
- 19 UNPAID AMOUNT IN ARREARAGE UNDER THE SUPPORT ORDER PURSUANT TO THE
- 20 SUPPORT ORDER. THE COURT MAY IMPOSE SUCH TERMS AND CONDITIONS IN
- 21 THE RESTITUTION ORDER AS ARE APPROPRIATE TO ENSURE COMPLIANCE WITH
- 22 PAYMENT OF THE ARREARAGE DUE UNDER THE SUPPORT ORDER. AN ORDER OF
- 23 RESTITUTION MAY INCLUDE A SEPARATE AWARD FOR DAMAGES CAUSED BY THE
- 24 INDIVIDUAL'S VIOLATION OF THIS SECTION THAT HAVE NOT BEEN ADDRESSED
- 25 IN ANOTHER COURT ORDER.
