SENATE BILL No. 569

October 1, 2013, Introduced by Senator MARLEAU and referred to the Committee on Health Policy.

A bill to amend 1972 PA 284, entitled "Business corporation act,"

by amending sections 282 and 284 (MCL 450.1282 and 450.1284), as added by 2012 PA 569.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 282. As used in this chapter:
- 2 (a) "Licensed person" means an individual who is duly licensed 3 or otherwise legally authorized to practice a professional service 4 by a court, department, board, commission, or agency of this state 5 or another jurisdiction. The term includes an entity if all of its 6 owners are licensed persons.
 - (b) "Professional service" means a type of personal service to the public that requires that the provider obtain a license or other legal authorization as a condition precedent to providing

- 1 that service. Professional service includes, but is not limited to,
- 2 services provided by a certified or other public accountant,
- 3 chiropractor, dentist, optometrist, veterinarian, osteopathic
- 4 physician, physician, surgeon, podiatrist, chiropodist, physician's
- 5 PHYSICIAN assistant, ADVANCED PRACTICE REGISTERED NURSE, NURSE
- 6 ANESTHETIST, architect, professional engineer, land surveyor, or
- 7 attorney-at-law.
- 8 Sec. 284. (1) Except as otherwise provided in subsection (2),
- 9 or (3), OR (4), if a professional corporation provides a
- 10 professional service that is subject to article 15 of the public
- 11 health code, 1978 PA 368, MCL 333.16101 to 333.18838, each
- 12 shareholder of the professional corporation must be licensed or
- 13 legally authorized in this state to provide the same professional
- 14 service.
- 15 (2) One or more individuals WHO ARE licensed to engage in the

- 17 medicine and surgery under part 175, 171, or the practice of

- 22 (5) (4)—A licensed person of another jurisdiction may become
- 23 an officer, agent, or employee of a professional corporation but
- 24 shall not provide any professional service in this state until the
- 25 person is licensed or otherwise legally authorized to provide the
- 26 professional service in this state.
