THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21517. (1) A HOSPITAL THAT USES A CHARGE DESCRIPTION
- 2 MASTER SHALL MAKE ITS CHARGE DESCRIPTION MASTER AVAILABLE BY
- 3 POSTING AN ELECTRONIC COPY OF THE CHARGE DESCRIPTION MASTER ON THE
- 4 HOSPITAL'S INTERNET WEBSITE. IF THE HOSPITAL HAS NO WEBSITE, IT
- 5 SHALL MAKE A WRITTEN OR ELECTRONIC COPY AVAILABLE AT THE HOSPITAL
- LOCATION. A HOSPITAL SHALL ALSO POST A CLEAR AND CONSPICUOUS NOTICE
- 7 IN ITS EMERGENCY DEPARTMENT, IF ANY, ADMISSIONS OFFICE, AND BILLING
- 8 OFFICE INFORMING PATIENTS THAT THE HOSPITAL'S CHARGE DESCRIPTION
- 9 MASTER IS AVAILABLE IN THE MANNER DESCRIBED IN THIS SUBSECTION. A

- 1 HOSPITAL SHALL NOT ENTER INTO ANY CONTRACT THAT PREVENTS IT FROM
- 2 MAKING ITS CHARGE DESCRIPTION MASTER AVAILABLE AS REQUIRED IN THIS

- 4 (2) ANY PERSON MAY FILE A CLAIM WITH THE DEPARTMENT ALLEGING A
- 5 VIOLATION OF THIS SECTION. THE DEPARTMENT SHALL INVESTIGATE AND
- 6 INFORM THE COMPLAINING PERSON OF ITS DETERMINATION WHETHER A
- 7 VIOLATION HAS OCCURRED AND WHAT ACTION IT WILL TAKE. THE DEPARTMENT

- 10 (3) AS USED IN THIS SECTION, "CHARGE DESCRIPTION MASTER" MEANS
- 11 A UNIFORM SCHEDULE OF CHARGES REPRESENTED BY THE HOSPITAL AS ITS
- 12 GROSS BILLED CHARGE FOR A GIVEN SERVICE OR ITEM, REGARDLESS OF
- 13 PAYER TYPE.
- 14 Enacting section 1. This amendatory act takes effect 1 year
- 15 after the date it is enacted into law.
