SENATE BILL No. 670

November 7, 2013, Introduced by Senators JONES, SCHUITMAKER, ANDERSON and JANSEN and referred to the Committee on Appropriations.

A bill to amend 1961 PA 236, entitled

"Revised judicature act of 1961,"

by amending section 181 (MCL 600.181), as amended by 2008 PA 545.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 181. (1) The justice system fund is created in the state treasury. The money in the fund shall be used as provided in this section.
 - (2) The state treasurer shall credit to the justice system fund deposits of proceeds from the collection of revenue from court assessments and costs designated by law for deposit in the fund and shall credit all income from investment credited to the fund by the state treasurer. The state treasurer may invest money in the fund in any manner authorized by law for the investment of state money.

- 3 unencumbered balance remaining in the fund at the end of a fiscal
- 4 year shall remain in the fund and shall not revert to the general

- (ii) To the jail reimbursement program fund created in section
- 20 629e of the Michigan vehicle code, 1949 PA 300, MCL 257.629e,
- 21 11.84% of the fund balance.
- 22 (iii) To the Michigan justice training fund created in section 5
- 23 of 1982 PA 302, MCL 18.425, 11.84% of the fund balance.
- 24 (iv) To the secretary of the legislative retirement system for
- 25 deposit with the state treasurer in the retirement fund created in
- 26 the Michigan legislative retirement system act, 1957 PA 261, MCL
- 27 38.1001 to 38.1080, **GENERAL FUND**, 1.10% of the fund balance.
