A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 916a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 916A. (1) THE PURPOSE OF THIS SECTION IS TO PROMOTE THE
- 2 HEALTH, SAFETY, AND GENERAL WELFARE OF THE CITIZENS OF THIS STATE
- 3 AND TO ESTABLISH REASONABLE AND UNIFORM REGULATIONS TO PREVENT THE
- 4 DELETERIOUS SECONDARY EFFECTS THAT ARE LIKELY TO ARISE FROM THE
- 5 COMBINATION OF ADULT ENTERTAINMENT AND ALCOHOLIC LIQUOR WITHIN THIS
- 6 STATE, INCLUDING, BUT NOT LIMITED TO, HEALTH AND SAFETY PROBLEMS IN
- 7 AND AROUND PUBLIC PLACES OF ADULT ENTERTAINMENT AND DANGEROUS AND
- 8 UNLAWFUL CONDUCT IN AND AROUND PUBLIC PLACES OF ADULT
- 9 ENTERTAINMENT. THIS SECTION IS UNRELATED TO THE SUPPRESSION OF

- 17 (B) "NUDITY" MEANS EXPOSURE TO PUBLIC VIEW OF THE WHOLE OR
- 18 PART OF THE PUBIC REGION; THE WHOLE OR PART OF THE ANUS; THE WHOLE
- 19 OR PART OF THE BUTTOCKS; THE WHOLE OR PART OF THE GENITALS; OR THE
- 20 BREAST AREA INCLUDING THE NIPPLE OR MORE THAN 1/2 OF THE AREA OF
- 21 THE BREAST.
- 22 (C) "SPECIFIED ANATOMICAL AREAS" MEANS LESS THAN COMPLETELY
- 23 AND OPAQUELY COVERED AND EXPOSED FOR PUBLIC VIEW OF THE WHOLE OR
- 24 PART OF THE PUBIC REGION; THE WHOLE OR PART OF THE ANUS; THE WHOLE
- 25 OR PART OF THE BUTTOCKS; THE WHOLE OR PART OF THE GENITALS; OR THE
- 26 BREAST AREA INCLUDING THE NIPPLE OR MORE THAN 1/2 OF THE AREA OF
- 27 THE BREAST.

- 1 (D) "SPECIFIED SEXUAL ACTIVITIES" MEANS WHERE THE PERSON
- 2 PERFORMS, OR SIMULATES PERFORMANCE OF, SEXUAL INTERCOURSE,
- 3 MASTURBATION, SODOMY, BESTIALITY, FELLATIO, OR CUNNILINGUS.
