SENATE BILL No. 715

December 5, 2013, Introduced by Senators CASPERSON, HUNE, ROBERTSON and SMITH and referred to the Committee on Insurance.

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding chapter 22A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER 22A

2 SEC. 2270. AS USED IN THIS CHAPTER:

(A) "CERTIFICATE OF INSURANCE" MEANS A DOCUMENT, REGARDLESS OF
HOW TITLED OR DESCRIBED, THAT IS PREPARED BY AN INSURER OR
INSURANCE PRODUCER THAT IS A STATEMENT OR SUMMARY OF AN INSURED'S
PROPERTY OR CASUALTY INSURANCE COVERAGE. CERTIFICATE OF INSURANCE
DOES NOT INCLUDE A POLICY OF INSURANCE, INSURANCE BINDER, POLICY
ENDORSEMENT, AUTOMOBILE IDENTIFICATION CARD, CERTIFICATE ISSUED
UNDER A GROUP OR MASTER POLICY, OR EVIDENCE OF COVERAGE PROVIDED TO
A LENDER IN A LENDING TRANSACTION INVOLVING A MORTGAGE, LIEN, DEED

- 2 (B) "DIRECTOR" MEANS THE DIRECTOR OF THE DEPARTMENT OF
- 3 INSURANCE AND FINANCIAL SERVICES.
- 4 (C) "INSURANCE" MEANS ANY OF THE LINES OF AUTHORITY IN CHAPTER
- 5 6.
- 6 (D) "INSURANCE PRODUCER" MEANS THAT TERM AS DEFINED IN SECTION
- 7 1201.
- 8 SEC. 2271. A PERSON SHALL NOT DO ANY OF THE FOLLOWING:
- 9 (A) ISSUE OR DELIVER A CERTIFICATE OF INSURANCE THAT PURPORTS
- 10 TO AFFIRMATIVELY OR NEGATIVELY ALTER, AMEND, OR EXTEND THE COVERAGE
- 11 PROVIDED BY AN INSURANCE POLICY REFERENCED IN THE CERTIFICATE OF
- 12 INSURANCE.
- 13 (B) PREPARE OR ISSUE A CERTIFICATE OF INSURANCE THAT CONTAINS
- 14 ANY FALSE OR MISLEADING INFORMATION CONCERNING AN INSURANCE POLICY
- 15 REFERENCED IN THE CERTIFICATE OF INSURANCE.
- 16 (C) DEMAND OR REQUIRE THE ISSUANCE OF A CERTIFICATE OF
- 17 INSURANCE FROM AN INSURER, INSURANCE PRODUCER, OR POLICYHOLDER THAT
- 18 CONTAINS ANY FALSE OR MISLEADING INFORMATION CONCERNING AN
- 19 INSURANCE POLICY REFERENCED IN THE CERTIFICATE OF INSURANCE.
- 20 SEC. 2272. A PERSON SHALL NOT ISSUE OR DELIVER A CERTIFICATE
- 21 OF INSURANCE UNLESS IT CONTAINS THE FOLLOWING OR SIMILAR STATEMENT:
- 22 "THIS CERTIFICATE OF INSURANCE IS ISSUED AS A MATTER OF
- 23 INFORMATION ONLY. IT DOES NOT CONFER RIGHTS UPON A PERSON
- 24 REQUESTING THE CERTIFICATE OF INSURANCE BEYOND WHAT AN INSURANCE
- 25 POLICY EXPRESSLY PROVIDES. THIS CERTIFICATE OF INSURANCE DOES NOT
- 26 EXTEND, AMEND, OR ALTER THE COVERAGE, TERMS, EXCLUSIONS, OR
- 27 CONDITIONS AFFORDED BY AN INSURANCE POLICY REFERENCED IN THIS

- 1 CERTIFICATE OF INSURANCE.".
- 2 SEC. 2273. EXCEPT AS OTHERWISE PROVIDED IN AN INSURANCE
- 3 POLICY, A CERTIFICATE OF INSURANCE DOES NOT REPRESENT AN INSURER'S
- 4 OBLIGATION TO GIVE NOTICE OF CANCELLATION OR NONRENEWAL TO A
- 5 PERSON.
- 6 SEC. 2275. A PERSON IS ENTITLED TO NOTICE OF CANCELLATION,
- 7 NONRENEWAL, AND ANY SIMILAR NOTICE CONCERNING A POLICY OF INSURANCE
- 8 ONLY IF THE PERSON HAS NOTICE RIGHTS UNDER THE TERMS OF A POLICY OF
- 9 INSURANCE OR AN ENDORSEMENT TO A POLICY OF INSURANCE. THE TERMS AND
- 10 CONDITIONS OF A NOTICE DESCRIBED IN THIS SECTION ARE GOVERNED BY
- 11 THE POLICY OF INSURANCE OR ENDORSEMENT. A CERTIFICATE OF INSURANCE
- 12 DOES NOT ALTER THE TERMS AND CONDITIONS OF THE NOTICE.
- 13 SEC. 2277. IF THE DIRECTOR FINDS THAT A PERSON HAS VIOLATED
- 14 THIS CHAPTER, AFTER AN OPPORTUNITY FOR A HEARING UNDER THE
- 15 ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO
- 16 24.328, THE DIRECTOR SHALL REDUCE THE FINDINGS AND DECISION TO
- 17 WRITING AND SHALL ISSUE AND CAUSE TO BE SERVED UPON THE PERSON
- 18 CHARGED WITH THE VIOLATION A COPY OF THE FINDINGS AND AN ORDER
- 19 REQUIRING THE PERSON TO CEASE AND DESIST FROM THE VIOLATION. IN
- 20 ADDITION, THE DIRECTOR MAY ORDER ANY OF THE FOLLOWING:
- 21 (A) PAYMENT OF A CIVIL FINE OF NOT MORE THAN \$500.00 FOR EACH
- 22 VIOLATION. HOWEVER, IF THE PERSON KNEW OR REASONABLY SHOULD HAVE
- 23 KNOWN THAT HE OR SHE WAS IN VIOLATION OF THIS CHAPTER, THE DIRECTOR
- 24 MAY ORDER THE PAYMENT OF A CIVIL FINE OF NOT MORE THAN \$2,500.00
- 25 FOR EACH VIOLATION. AN ORDER OF THE DIRECTOR UNDER THIS SECTION
- 26 SHALL NOT REQUIRE THE PAYMENT OF CIVIL FINES EXCEEDING \$25,000.00.
- 27 A FINE COLLECTED UNDER THIS SUBDIVISION SHALL BE TURNED OVER TO THE

- 1 STATE TREASURER AND CREDITED TO THE GENERAL FUND OF THIS STATE.
- 2 (B) THE DIRECTOR MAY APPLY TO THE CIRCUIT COURT OF INGHAM
- 3 COUNTY FOR AN ORDER OF THE COURT ENJOINING A VIOLATION OF THIS
- 4 CHAPTER.
