SENATE BILL No. 732

January 8, 2014, Introduced by Senators ANANICH, WHITMER, WARREN, YOUNG, HOOD, HOPGOOD, GREGORY, JOHNSON, SMITH, ANDERSON and BIEDA and referred to the Committee on Government Operations.

A bill to prohibit an employer from making certain personal inquiries of employees or applicants for employment; to prohibit discrimination and retaliation for actions to enforce the prohibition on personal inquiries; and to provide remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. (1) This act shall be known and may be cited as the
 "employee contraceptive privacy act".
 - (2) As used in this act, "employer" means a person who has 1 or more employees and includes an agent of that person.
 - Sec. 2. An employer shall not do any of the following:
 - (a) Inquire as to an employee's or applicant for employment's use or nonuse of contraceptives.
 - (b) Discriminate against an employee or applicant for

- 1 employment for failure to provide information concerning use or
- 2 nonuse of contraceptives.
- 3 (c) Retaliate or discriminate against an employee because the
- 4 employee has made a charge, filed a complaint, testified, assisted,
- 5 or participated in an investigation, proceeding, or hearing
- 6 concerning an alleged violation of this act.
- 7 Sec. 3. (1) A person alleging a violation of this act may
- 8 bring a civil action for appropriate injunctive relief or damages,
- 9 or both.
- 10 (2) An action commenced pursuant to subsection (1) may be
- 11 brought in the circuit court for the county where the alleged
- 12 violation occurred or for the county where the individual or entity
- 13 against whom the civil complaint is filed resides or has its
- 14 principal place of business.
- 15 (3) As used in subsection (1), "damages" means damages for
- 16 injury or loss caused by each violation of this act, including
- 17 reasonable attorney fees.
