

SENATE BILL No. 807

February 20, 2014, Introduced by Senators ANANICH, WARREN, CASWELL, MARLEAU, BOOHER, ROBERTSON, SCHUITMAKER, CASPERSON, BIEDA, ROCCA, ANDERSON, COLBECK, JANSEN, HOPGOOD, JONES, WHITMER, HANSEN, NOFS, PAPPAGEORGE, EMMONS, HILDENBRAND, KOWALL, MOOLENAAR and JOHNSON and referred to the Committee on Health Policy.

A bill to amend 1984 PA 233, entitled
"Prudent purchaser act,"
by amending section 2 (MCL 550.52).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2. As used in this act:

2 (a) "Commissioner" means the commissioner of insurance.

3 (b) "Dental care corporation" means a dental care corporation
4 incorporated under ~~Act No. 125 of the Public Acts of 1963, being~~
5 ~~sections 550.351 to 550.373 of the Michigan Compiled Laws.1963 PA~~
6 **125, MCL 550.351 TO 550.373.**

7 (c) "Health care corporation" means a health care corporation
8 incorporated under the nonprofit health care corporation reform

 2 ~~550.1101 to 550.1704 of the Michigan Compiled Laws.~~ **1980 PA 350, MCL**

4 (d) "Health care provider" means a health facility or a person
 5 licensed, certified, or registered under ~~parts 61 to 65~~ **PART 62** or
 6 **PARTS** 161 to 182 of the public health code, ~~Act No. 368 of the~~
 7 ~~Public Acts of 1978, being sections 333.6101 to 333.6523 and~~
 8 ~~333.16101 to 333.18237 of the Michigan Compiled Laws.~~ However,
 9 ~~health~~ **1978 PA 368, MCL 333.6230 TO 333.6251 AND 333.16101 TO**
 10 **333.18237, AND CHAPTER 2A OF THE MENTAL HEALTH CODE, 1974 PA 258,**

 17 **333.21799E**, or a licensed part thereof, ~~except a facility or agency~~
 18 ~~licensed under part 203 of the public health code.~~ **OF THAT FACILITY**
 19 **OR AGENCY. HEALTH FACILITY DOES NOT INCLUDE AN AMBULANCE OPERATION,**
 20 **AIRCRAFT TRANSPORT OPERATION, NONTRANSPORT PREHOSPITAL LIFE SUPPORT**
 21 **OPERATION, OR MEDICAL FIRST RESPONSE SERVICE.**

22 (ii) A mental hospital, psychiatric hospital, psychiatric unit,

21 (g) "Hospital service corporation" means a hospital service
22 corporation incorporated under ~~Act No. 109 of the Public Acts of~~
23 ~~1939, being sections 550.501 to 550.517 of the Michigan Compiled~~
24 ~~Laws.~~ **FORMER 1939 PA 109.**

25 (h) "Insurer" means an insurer as defined in section 106 of
26 the insurance code of 1956, ~~Act No. 218 of the Public Acts of 1956,~~
27 ~~being section 500.106 of the Michigan Compiled Laws.~~ **1956 PA 218,**

2 (i) "Medical care corporation" means a medical care
3 corporation incorporated under ~~Act No. 108 of the Public Acts of~~
4 ~~1939, being sections 550.301 to 550.316 of the Michigan Compiled~~
5 ~~Laws.~~ **FORMER 1939 PA 108.**

6 (j) "Organization" means an insurer, a dental care
7 corporation, hospital service corporation, medical care
8 corporation, health care corporation, or third party administrator.

9 (k) "Provider panel" means a panel of health care providers
10 providing health care services pursuant to a prudent purchaser
11 agreement.

12 (l) "Prudent purchaser agreement" means an agreement between an
13 organization and a health care provider pursuant to section 3.

14 (m) "Third party administrator" means an administrator
15 operating under a certificate of authority issued by the
16 commissioner pursuant to the third party administrator act.
