September 9, 2014, Introduced by Senator WHITMER and referred to the Committee on Government Operations.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by amending the heading of chapter 5 of article II and by adding part 162.

- 11 (D) "PLASTIC MICROBEAD" MEANS ANY INTENTIONALLY ADDED NON-
- 12 BIODEGRADABLE PLASTIC PARTICLE LESS THAN 5 MILLIMETERS IN EACH
- 13 DIMENSION AND USED TO EXFOLIATE OR CLEANSE IN A RINSE-OFF PRODUCT.
- 14 SEC. 16202. A PERSON SHALL NOT DO ANY OF THE FOLLOWING:
- 15 (A) BEGINNING JANUARY 1, 2018, MANUFACTURE FOR SALE A PERSONAL
- 16 CARE PRODUCT, EXCEPT FOR AN OVER-THE-COUNTER DRUG, THAT CONTAINS
- 17 PLASTIC MICROBEADS.
- 18 (B) BEGINNING JANUARY 1, 2019, ACCEPT FOR SALE A PERSONAL CARE
- 19 PRODUCT, EXCEPT FOR AN OVER-THE-COUNTER DRUG, THAT CONTAINS PLASTIC
- 20 MICROBEADS.
- 21 (C) BEGINNING JANUARY 1, 2019, MANUFACTURE FOR SALE AN OVER-
- 22 THE-COUNTER DRUG THAT CONTAINS PLASTIC MICROBEADS.
- 23 (D) BEGINNING JANUARY 1, 2020, ACCEPT FOR SALE AN OVER-THE-
- 24 COUNTER DRUG THAT CONTAINS PLASTIC MICROBEADS.
- 25 SEC. 16203. (1) SUBJECT TO SUBSECTION (2), A PERSON WHO
- 26 VIOLATES SECTION 16202 MAY BE ORDERED TO PAY A CIVIL FINE OF NOT
- 27 MORE THAN \$1,000.00 PER DAY FOR EACH PERSONAL CARE PRODUCT THAT IS

- 1 THE SUBJECT OF A VIOLATION.
- 2 (2) A PERSON WHO VIOLATES SECTION 16202 A SECOND OR SUBSEQUENT
- 3 TIME MAY BE ORDERED TO PAY A CIVIL FINE OF NOT MORE THAN \$2,500.00
- 4 PER DAY FOR EACH PERSONAL CARE PRODUCT THAT IS THE SUBJECT OF A
- 5 VIOLATION.
- 6 (3) A VIOLATION OF SECTION 16202 MAY BE PROSECUTED BY THE
- 7 PROSECUTING ATTORNEY OF THE COUNTY WHERE THE VIOLATION OCCURRED OR
- 8 BY THE ATTORNEY GENERAL.
