A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 547.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 547. (1) THE FAILURE OF THE CIRCULATOR OR AN ELECTOR WHO
- 2 SIGNS A PETITION TO PRINT HIS OR HER NAME, TO PRINT HIS OR HER NAME
- 3 IN THE LOCATION PRESCRIBED BY THE SECRETARY OF STATE, OR TO ENTER A
- 4 ZIP CODE OR HIS OR HER CORRECT ZIP CODE DOES NOT AFFECT THE
- 5 VALIDITY OF THE SIGNATURE OF THE CIRCULATOR OR THE ELECTOR WHO
- 6 SIGNS THE PETITION. A PRINTED NAME LOCATED IN THE SPACE PRESCRIBED
- 7 FOR PRINTED NAMES DOES NOT CONSTITUTE THE SIGNATURE OF THE
- 8 CIRCULATOR OR ELECTOR. IF AN ELECTOR DOES NOT INCLUDE HIS OR HER
- 9 SIGNATURE, HIS OR HER STREET ADDRESS OR RURAL ROUTE, OR THE DATE OF
- 10 SIGNING ON A PETITION AS REQUIRED UNDER SECTION 544C(1), THE
- 11 ELECTOR'S SIGNATURE IS INVALID AND SHALL NOT BE COUNTED BY A FILING

- 2 (2) THE CIRCULATOR OF A PETITION SHALL SIGN AND DATE THE
- 3 CERTIFICATE OF CIRCULATOR BEFORE THE PETITION IS FILED. A

- 5 CIRCULATOR HAS SIGNED AND DATED THE CERTIFICATE OF CIRCULATOR. A

- 10 (3) EXCEPT AS PROVIDED IN SECTION 544D, A PETITION SHEET SHALL

- 12 OF A PETITION SHEET SHALL BE A REGISTERED ELECTOR OF THE CITY OR
- 13 TOWNSHIP INDICATED IN THE HEADING OF THE PETITION SHEET. THE
- 14 INVALIDITY OF 1 OR MORE SIGNATURES ON A PETITION DOES NOT AFFECT
- 15 THE VALIDITY OF THE REMAINDER OF THE SIGNATURES ON THE PETITION.
- 16 (4) AN INDIVIDUAL SHALL NOT SIGN A PETITION MORE THAN ONCE. AN
- 17 INDIVIDUAL SHALL NOT SIGN MORE NOMINATING PETITIONS FOR THE SAME
- 18 OFFICE THAN THERE ARE PERSONS TO BE ELECTED TO THE OFFICE. AN
- 19 INDIVIDUAL WHO VIOLATES THIS SUBSECTION IS GUILTY OF A MISDEMEANOR.
- 20 (5) AN INDIVIDUAL SHALL NOT DO ANY OF THE FOLLOWING:
- 21 (A) SIGN A PETITION WITH A NAME OTHER THAN HIS OR HER OWN.
- 22 (B) MAKE A FALSE STATEMENT IN A CERTIFICATE ON A PETITION.
- 23 (C) IF NOT A CIRCULATOR, SIGN A PETITION AS A CIRCULATOR.
- 24 (D) SIGN A NAME AS CIRCULATOR OTHER THAN HIS OR HER OWN.
- 25 (6) AN INDIVIDUAL WHO VIOLATES SUBSECTION (5) IS GUILTY OF A
- 26 MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN \$500.00 OR
- 27 IMPRISONMENT FOR NOT MORE THAN 93 DAYS, OR BOTH.

(7) AN INDIVIDUAL SHALL NOT SIGN A PETITION WITH MORE THAN 1 1 2 NAME OTHER THAN HIS OR HER OWN. AN INDIVIDUAL WHO VIOLATES THIS 3 SUBSECTION IS GUILTY OF A FELONY. (8) A PERSON WHO AIDS OR ABETS ANOTHER IN AN ACT THAT IS 4 5 PROHIBITED BY THIS SECTION IS GUILTY OF THAT ACT. Enacting section 1.
