House Bill 4388 would amend section 1212 of the Revised School Code (MCL 380.1212) to revise sinking fund millages by decreasing the maximum allowable number of mills and duration, as well as expand allowable uses. A more detailed description of the bill follows.

BACKGROUND:

A sinking fund is a savings account into which a local school district can deposit voter-approved local millage revenue in order to pay cash for projects or repairs as they arise rather than having to borrow through short-term notes or long-term bonds. Sinking funds provide districts with a cost-effective alternative to borrowing or bonding for some expenditures because they require none of the associated interest costs nor legal fees. Presently there are 170 districts out of 545 local districts levying sinking fund millages, and they generate an estimated \$131.0 million in revenue statewide. (See <u>Appendix</u> for a list of districts and their current sinking fund mills.)

Currently under statute, the board of a school district may, with voter approval, levy a property tax (millage) in the school district each year under the following conditions:

- <u>Millage and Duration</u>: A sinking fund may be authorized up to a *maximum of 5 mills* for a period *not to exceed 20 years*.
- <u>Allowable Use</u>: A sinking fund may be used for the purchase of real estate for school construction and for the construction and repair (but not maintenance) of school buildings.

SUMMARY:

House Bill 4388 would grandfather in all sinking funds authorized prior to its enactment with regard to millage amount, duration, and purpose as described above. However, for any sinking fund authorized after the bill's enactment, the following would apply:

- <u>Millage and Duration</u>: A sinking fund could be authorized up to a *maximum of 3 mills* for a period *not to exceed 10 years*.
- <u>Allowable Use</u>: In addition to existing purposes, a sinking fund could be used for school security improvements, or the acquisition or upgrading of technology. The additional purposes would be defined by the bill as follows:

- School security improvements would be defined as any capital improvement or purchase designed to deter unauthorized persons or items onto school premises or to otherwise promote security, including, but not limited to, metal detectors, locks, doors, lighting, cameras, and enhancements to entryways. It would also include a mobile telephone application that provides the ability to communicate with personnel on site while also connecting an emergency telephone call to a 911 center. It would not include personnel costs or operation costs related to a capital improvement or purchase or related to a mobile telephone application.
- <u>Technology</u> would be defined as it is under section 1351a of the Revised School Code (MCL 380.1351a) and would mean hardware and communication devices that transmit, receive, or compute information for pupil instructional purposes, along with the accompanying initial purchase of operating system software or custom application software and their design and installation.

FISCAL IMPACT:

House Bill 4388 would have no fiscal impact on the state and an indeterminate fiscal impact on local school districts. The bill would not affect current, voter-approved sinking funds for local school districts, but would have a fiscal impact on districts for future sinking fund millages.

First, the bill would reduce potential sinking fund revenue by reducing the maximum allowable millage levied from 5 mills to 3 mills. Currently, of the 170 districts that levy sinking funds, 12 districts levy more than 3 mills (See <u>Appendix</u> for a list of districts and their current millage rates). If the revised cap were in effect today, it would have reduced overall sinking fund revenue in those 12 districts by approximately \$2.8 million.

Second, the bill could reduce potential sinking fund revenue by reducing the maximum duration of the levy from 20 years to 10 years. However, rather than an actual revenue reduction, the likely impact of this would be that a district would choose instead to incur the costs of having an additional ballot question to renew it after 10 years rather than 20.

Third, to the extent that expanding the allowable use of sinking funds could translate to an increase in sinking fund millage rates or the number of districts utilizing sinking funds, the bill could generate additional millage revenue for districts and allow a district to reprioritize general operating funds that would otherwise support security and technology for other activities. However, if a district that otherwise would have sought a bond millage for security and technology, instead uses a sinking fund for those purposes, the overall number of mills levied per district could remain the same while eliminating the legal and interest costs related to a bond that do not exist for a sinking fund. There is not enough information available with which to estimate the effect the bill would have on either school district or voter behavior.

For background, the <u>table</u> below shows the growth in the number of districts levying sinking funds and the change in the average sinking fund millage rates since 1997 (the years for which

we have data readily available). The number of districts utilizing this financing mechanism has grown from 36 districts in FY 1997 to 170 districts in FY 2016 (See <u>Appendix</u> for a list of districts and their current sinking fund mills). While the number of districts has quadrupled in that time, the number using sinking funds today represents approximately one-third of all local districts.

Additionally, while the *average sinking fund millage rate for districts with sinking funds* initially rose during the first few years of this time period, it has gradually decreased since from a high of 1.791 in 1999 to 1.355 today. In FY 2016, 59 percent of districts levy 1.0 mill or fewer, another 34 percent levy between 1.0 and 3.0 mills, and 7 percent levy more than 3.0 mills.

The <u>table</u> below also includes data on the growth of the *statewide average sinking fund millage across all districts*, which has grown from 0.101 in FY 1997 to 0.423 in FY 2016. The growth in the statewide average among all districts is due to the growth in the number of districts using sinking funds despite the fact that they have been levying a decreasing average number of mills.
